TERMS AND CONDITIONS

- 1). **Prices :** Prices should be firm in rupees. The basic price, taxes and duties shall be clearly furnished as indicated in schedule of quantity and price in Form-III (B) enclosed.
- 2). **LOSS OR DAMAGE:** a) External damages or shortages that are prima facie the results of rough handling in transit or due to defective packing will be intimated within a fortnight of the receipt of the materials. Internal defects or shortages of any integral parts which cannot ordinarily be detected on a superficial visual examination though due to bad handling in transit of defective packing will be intimated within **(2) months** from the date of receipt of these articles, In either case the damaged or defective materials should be replaced by you free of cost to the TSTRANSCO.

b). Where any materials supplied by the tenderer are found to be defective in whole or in part within the guarantee period will be intimated of the same and should be take immediate steps to rectify the defect or to replace the defective materials free of cost. If no steps are taken within 15 Days of receipt of intimation of defects or such other reasonable time as the TSTRANSCO may deem proper to afford without prejudice to its other rights and remedies, cause to be repaired or rectified, the defective materials or replace the same and recover the expenditure incurred therefore from the deposits such as EMD, SECURITY DEPOSIT AND PERFORMANCE or other money available with the TSTRANSCO or by resorting to legal action and also decline to accept further deliveries of materials.

c). The defective portion of whole of the materials so replaced or renewed should give satisfactory performance till the expiration of six months from the date of such replacement or renewal or until the end of guarantee period whichever may be latter.
- 3). **Payment:** 90% of the due price will be paid within 30 days after receipt of the goods in good condition and on receipt of suppliers bill in duplicate supported by duplicate copy of invoice duly certified by the consignee and balance 10% due on goods received in good condition will be made after completion of guaranteed performance period.

Payment for the materials supplied will be made by crossed cheque payable at any scheduled bank of Head quarters of the paying officer.
- 4). **Acceptance:** It is not binding on the purchaser to accept the lowest or any tender. The purchaser reserves the right to place orders with different firms. The quantities are also subject to modification at the time of placing the orders.
- 5). **LEAFLETS & DESCRIPTIVE LITERATURE :** Full descriptive particulars and working drawings of the materials offered should accompany the tender. Information regarding the country of manufacture origin of materials used in the manufacturing of the articles should be furnished.
- 6). **Delivery :** The materials shall have to be supplied within 60 days from the date of receipt of the order.
- 7). **Penalty for late Delivery :** In case of delay in delivery of materials the purchaser may at his option, impose a penalty for delayed supply @ ½ % per week for the value of goods undelivered, subject to the maximum of 5% of total value of purchase order.

If you fail to supply the materials before the expire of 3 months from stipulated delivery time, the TSTRANSCO reserves the right to cancel the order forfeiting the Security Deposit, without prejudice to the claim for damages caused to the TRANSCO on account of such failure on the part of you.

- 8). **E.M.D. :** Earnest money deposit equivalent to 2 ½ % of the contract value should be furnished in shape of crossed DD drawn in favour of the Superintending Engineer/OMC/TSTRANSCO/Adilabad, payable at **Mancherial** along with the tender. If P.E.M.D. facility is available the same may furnished. E.M.D. paid will be returned in the case of un-successful tender.
- 9). **Security Deposit:** The successful tenderer should furnish a Security deposit to 2 ½ % of the total value in shape of crossed D.D. drawn in favour of Superintending Engineer/OMC/Adilabad, payable at Mancherial. In case of those who pay the EMD, it will be adjusted towards security deposits if the order is placed on them. If a PSD facility is available, the same may be furnished.
