TERMS & CONDITIONS

Name of the work: Replacement of existing ADSS cable with 24 F OPGW cable on 400KVSS Dichpally – 220KVSS Dichpally Ckt 1 & 2.

Firm Price: Price quoted shall be Firm for the contract period. Price variation is not applicable for this contract.

1. The E.M.D. will be refunded to the unsuccessful tenders after finalisation of tenders.
For successful bidders the E.M.D. will be adjusted towards the payment of Security Deposit.
2. The E.M.D. will be forfeited in the following cases:
 - a) When the successful bidder does not accept the order after issue of letter of intent / acceptance letter.
 - b) When the successful bidder fails to furnish the security deposit within specified period after issue of letter of intent/acceptance letter.
 - c) When tender is disqualified.
 - d) When the bidder alters his prices or withdraws his offer during the validity period.
3. SECURITY DEPOSIT: Contractor has to pay within 15 days from the date of issue of the orders, equal to 5% of the total value of the contract as security deposit. The security deposit shall be paid in shape of Demand Draft drawn in favour of the Superintending Engineer/Telecom Circle/TS TRANSCO/Warangal payable at State Bank of India, Main branch, Warangal. No interest will be paid on security deposit. The security deposit will be released after completion of 12 months of completion of work.
4. PAYMENT TERMS:
90% Payment will be made based on the bills of the contractor after certification of work done by the officers in charge of the work and following all the rules in vogue and balance 10% of payment will be released after completion of work.
5. If the contractor has received any over payment by mistake or if any amounts from the TSTRANSCO due to any other reason, when it is not possible to recover such amounts under the Contract recovering the same from any other amounts and Bank Guarantee given by the contractor due to or with the TSTRANSCO.
6. The work should be completed within 60 days from the date of handing over of site. The work should be carried out as per the schedule enclosed.

7. GST:

- i) GST No. of TSTRANSCO is 36 AAFCT0166J1Z9 and shall be quoted on their invoice.
- ii) The GST Registration number of Supplier shall to be quoted on each invoice.
- iii) Tax invoice shall contain SGST and CGST breakup (or IGST) along with HSN Code.
- iv) Suppliers who have opted for composition scheme in GST shall not charge GST in their invoice. Supplier shall submit the Bill of supply without charging GST stating on the top of their Bill of Supply that "Composition taxable person, not eligible to collect tax on supplies".
- v) The input tax credit claimed by registered taxable person should commensurate reduction in the price of goods and services supplied to TSTRANSCO.
- vi) TDS @ 2% for GST will be recovered under remitted directly to the Government as per section 51 of CGST/SGST at 2017 and section 20 of IGST act 2017 read with notification No.33/2017. Central tax dated 15-09-2017 for contractor above 2.5 lakhs.
- vii) Valid Email address shall be mentioned on the Invoice to send TDS certificate.

8. Labour Cess @1% will be deducted from the bills.

- 10. Penalty Clause: The work shall be completed within stipulated time. If the work is delayed without any reasonable cause a penalty of 0.5% on the Agreement value per week will be imposed as penalty not exceeding 5% of maximum of Agreement value at the discretion of SE/Telecom/Karimnagar.
- 11. GUARANTEE: The contractor should stand guarantee for workmanship for a period of 12 months from the date of completion of work.
- 12. If any accident occurs to the contractor or to his labour during the course of work or outside, the Contractor only will be held responsible and for any compensation to be paid, the contractor has to pay. The TSTRANSCO is not responsible and if the contractor does not pay such Compensation as settled by the courts or labour departments, the TSTRANSCO will recover such amount from any of the bills of the contracts held with TSTRANSCO.
- 13. The contractor should provide all statutory requirement and facilities to the workers engaged at his own cost.
- 14. The work under execution is to be done under the supervision of Contractor's supervisor, as per the instructions of TSTRANSCO Engineer at site.

15. The contractor should arrange accommodation and boarding to the workers engaged by him for the work, at his own cost nearer to the work spot.
16. For any reason if the work is delayed, stopped, interrupted or trying to postpone the work without any reasonable cause to the satisfaction TSTRANSCO Engineers, the loss sustained by the TSTRANSCO due to above inconvenience shall be paid by the contractor.
17. Every care should be taken by the Contractor for his labour while doing the work so as to not to damage the TSTRANSCO equipment, properties, T&P, etc. In case of any damage, the contractor is responsible and shall pay the damages sustained.
18. The contractor shall comply with all state and central laws, statutory rules, regulations etc., such as payment of wages act, minimum wages act, workmen compensation act, employees liabilities act, industrial disputes act etc., and EPF scheme and other acts as directed by Government during the tenure of contract period.
19. What so ever may be reason, no extra payment will be made by TSTRANSCO other than the agreed rates at a later date.
20. Medical facilities for the labour engaged by the contractor should be arranged at his own cost.
21. The contractor's personnel should follow all the rules in vogue at site.
22. In case, the work carried out is not satisfactory to the Engineer of TSTRANSCO, the Superintending Engineer /Telecom / TSTRANSCO / Karimnagar reserves the right to terminate the contract with 7 days notice and get the balance work done by other agencies and recover the cost if any from the amounts of the bidder available with TSTRANSCO.
23. No part of the contract shall be sublet without written permission of Superintending Engineer /Telecom/TSTRANSCO/Karimnagar nor shall be transferred on power of attorney authorizing others to receive payments on contractors behalf.
24. All and any disputes and differences arising out of the contracts or touching the contract shall be decided in the courts of law situated in Karimnagar.
25. Furnish the declaration regarding relationship with Transco employees. If false information is furnished in the declaration regarding "Relationship with Transco employees" it will render the contract liable for termination as well as recovery of damages.
