#### **TERMS AND CONDITIONS**

**1.** NAME OF THE WORK: Supply of 1 No. Utility Van for official use of the Assistant Divisional Engineer, Telecom, ALDC, Warangal on monthly hire Basis for the period from 01.04.2024 to 31.03.2025.

#### 2. FILLING OF SCHEDULE:

The works contract will be awarded to registered contractors having Registration with TSTRANSCO for carrying out of the above work. They only are eligible to participate in Tenders. The Tender schedule should be filled properly and the rates should be quoted for carrying out the above said work in the Telecom Circle, Warangal during the prescribed period, as per the conditions stipulated for guaranteed performance in a sealed cover to the **Superintending Engineer**, **Telecom Circle**, **Room No. 118**, **220 KVSS**, **Mulugu Road**, **Warangal – 506007**. The maximum contract period is 12 months and will be cancelled as and when departmental vehicle are provided for the officers mentioned in the subject.

The envelope containing sealed tender must be with superscription indicating (1) Tender Specification No. (2) Name of the Work (3) Details of Bid cost & EMD paid (i.e.) D.D. No. Date and Amount (or) Details of PEMD in case of PEMD holder or Certificate of exemption with TSTRANSCO in case of SC/ST/Waddera/Sagara (4) Registration Number with TSTRANSCO, Data of Validity of the above registration (5) Tender opening date & time (6) Validity of the Tender. The Tenders without the above details on the envelope will be rejected. Rates should be quoted both in figures and works. The Corrections, if any, shall be authenticated with full signature. Unauthenticated corrections are liable for rejection.

Tenderer has to enclose to his Tender a copy of Validy registration certificate issued by TSTRANSCO and copy of Valid PEMD in case of PEMD holder or certificate of exemption by TSTRANSCO in case of SC/ST/Waddera/Sagara Categories for EMD (Demand Draft) and any other relevant attested copied of certificates.

#### 3. COST OF BID/TENDER SPECIFICATION:

The cost of the Tender Specification/Bid is ₹ 590/- and should be paid by the way of Demand Draft in favour of the Superintending Engineer, Telecom Circle, TSTRANSCO, Warangal payable at Warangal should be enclosed to the Tender. #### 4. EARNEST MONEY DEPOSIT:

EMD @ 2.5% on value of the work by way of crossed demand draft drawn in favour of "Superintending Engineer, Telecom Circle, TS TRANSCO, Warangal" Payable at Warangal should Terms and Conditions are accepted.

The E.M.D. will be refunded in the case of unsuccessful Tenderers after finalization of Tenders. The E.M.D. will be adjusted towards Security Deposit in case of Successful Tenderer. No interest will be paid on E.M.D. The E.M.D. is exempted for the Tenders belonging to SC/ST/Waddera/Sagara categories for the works amounting up to ₹ 20,00,000/- (Rupees Twenty Lakhs only). The Tenderer belonging to SC/ST/Waddera/Sagara categories must enclosed the certificate of exemption of TSTRANSCO along with specification.

#### 5. PERIOD OF CONTRACT:

The period of Contract is from 01.04.2024 or from the date of actual utilization to 31.03.2025. The TSTRANSCO has right to terminate the contract without assigning any reasons for unsatisfactory performance on the part of the travelling agency by giving 15 days notice and no compensation will be paid for the balance period of contract. The hiring of the vehicle will be stopped if the officer for whom the vehicle was provided goes on Transfer/Promotion/Leave and also if the post is vacant.

#### 6. EXPERIENCE:

The Tenderer should be a reputed agency in Business for the past two years at least.

#### 7. SECURITY DEPOSIT:

The Successful Tenderer has to pay Security Deposit equal to 5% of the value of Contract by way of Crossed Demand Draft drawn in favour of "Superintending Engineer, Telecom Circle, TS TRANSCO, Warangal" payable at Warangal. The Security Deposit will be released after satisfactory completion of work entrusted, which will not carry any interest. The Security Deposit shall be forfeited if the Contractors do not full-fill the Terms and Conditions of the Works Contract.

#### 8. VALIDITY:

The quotation shall be valid for 90 days.

#### 9. AGREEMENT:

The successful Tenderer should enter into an Agreement on Non-Judicial Stamped paper for the value specified by the Superintending Engineer, Telecom Circle, TS TRANSCO, Warangal.

The hiring agency should give two months prior notice to TSTRANSCO, if the agency desires to withdraw the vehicle during the agreement period otherwise the agency's Security Deposit will be forfeited.

#### 10. <u>RATES:</u>

- (a) The rates and prices quoted by the Tenderer while submitting the Tender shall be firm till the work is completed. The Quoted rates shall be binding on the Tenderer even for the award of part work.
- (b) The Form of Contract will be Lump Sum.

#### 11. **INSURANCE**:

All vehicles proposed to be supplied to the Transmission Corporation of Telangana Limited should invariably have comprehensive General Policies for the period of Contract. The Transmission Corporation of Telangana Limited shall not be responsible for any kind of litigation, what ever, in case of breakdown, accidents etc., only the supplier of sole proprietor or agency shall be responsible for settlement of any such claims arising out of accidents.

Terms and Conditions are accepted.

#### 12. M.V. TAX & REGISTRATION:

M.V. Tax in respect of all the vehicles proposed to be supplied to TS TRANSCO should invariably be paid for the contract period and they should be reputed as Taxies with Statewide permit. For any journeys outside Telangana, required permission shall be obtained by the Contractor and TS TRANSCO will reimburse the same at actual on production of receipt issued by RTA. All the Vehicles shall have valid pollution under control certificate issued by RTA or authorized agency and must renewed as and when falls due during the period of contract.

#### 13. DRIVERS:

The Drivers of the vehicle shall be covered under a Group Insurance Policy.

All the drivers of the vehicles should posses valid L.V. Driver's (Professional License). It is preferred that the same driver and vehicle serve each officer continuously. Frequent changes causing inconvenience to the officers may entail cancellation of the Hiring of the Vehicle and the additional cost in Hiring alternate Vehicle shall be on the account of the Contractor. The Driver engaged shall be well dressed and will mannered and should conduct himself in a respectable manner and he shall be provided with Identity Card issued by the agency to displayed at all times on duty.

The agency is responsible for obtaining licenses under the Contract Labour (Regulation and Abolition) Act: 1970. In case the provisions of the Act have no application to the agency it is his responsibility to obtain "Not Applicable" Certificate from the Appropriate Authority.

#### 14. SCOPE OF THE WORK:

The scope of the work includes providing the 1 No. Utility Van with a mileage of 2500 KM's per month on monthly Hire Basis.

#### 15. MODEL & CONDITION OF VEHICLES:

Vehicles of latest models with state wide permit shall only be considered for hiring during the period of contract. The Vehicle should be maintained in perfect condition and road worthy always.

#### 16. INSPECTION:

The Vehicle shall be put up for inspection along with the original Documents like "RC" (Registration Certificate), Insurance Policy, Taxi Permit, Valid Pollution under Control Certificate etc., to the inspecting officer authorized by TS TRANSCO and when requisitioned. The successful bidder shall make the Vehicle available for inspection before actually providing the same to TSTRANSCO officer. Vehicle not confirming to this specification will be rejected.

#### 17. BREAKDOWN OF THE VEHICLE:

In case of vehicle Breakdown, the supplier should provide a replacement of vehicle in good condition with in one hour of receiving such report. The supplier should maintain spare vehicle of the same standards to meet such emergencies. In the event of contractor's failure do so, the TS TRANSCO may hire an alternate vehicle, at the cost of the contractor besides imposing penalty at the rate of Rs. 500/- per day. If the Department not engaged the other vehicle, the cost of vehicle for that absent days will be recovered along with penalty.

#### 18. REKONING OF KM's AND TIME:

The reckoning of KM's will be connected from the head quarters or from the garage of the agency (whichever distance is less) to the designated place by the officer using the vehicle.

Terms and Conditions are accepted.

#### 19. ELEGIBILITY CRETERIA:

- (i) The Tenderer should be a reputed agency in business for the past two years at least.
- (ii) The Tenderer shall enclose list of Vehicles available with them along with year of manufacture, vehicle wise and to whom they have provided in the past, with list of clients, with Hire details. The RC shall be in the name of the agency or its Sole Proprietor.

#### 20. LIABILITY:

TS TRANSCO shall not be responsible for any liability or damages suffered by the Tenderer of the Vehicle entrusted on hire or its driver during the course of the hire period, any out of but not restricted to accidents, demonstrations, riots, natural calamities, strikes, fire etc.

#### 21. GST (GOOD & SERVICE TAX):

The GST as applicable on quoted value will be borne by the TSTRANSCO. A copy of GST Registration is to be enclosed along with Bid in case agency is GST Registered. Otherwise, an undertaking stating that the agency will not come under the purview of GST as per the GST guidelines shall be enclosed to the Bid.

#### 22. TOLL GATE FEE:

The Toll Gate fee as per actuals will be borne by the TSTRANSCO.

#### **23. PAYMENT :**

The monthly Bills will paid with in 90 days duly deducting the applicable be Tax Statutory after the submission of Bills in duplicate. Income **Payment** will the office of the Superintending Engineer, be arranged from TRANSCO, Telecommunications, TS Warangal submission of bills after on identifying officers. The payment will not be made for certification by the any unauthorized trips.

- 24. The Owner / Manager or the agency providing vehicles to the field officers shall not be related to any of the employees and officers / Directors of TS TRANSCO / DISCOMS / TS GENCO. An undertaking to these effects should be submitted by the agency if the agency is successful after finalization of Tenders.
- **25.** TS TRANSCO shall not be liable for payment of any penalties claimed by concerned authorities for all offences punishable under law.
- **26.** Any violation of the terms & conditions of the contract by the agency will be treated as the breach of contract and the contract will be terminated immediately duly forfeiting the Security Deposit available with the department.
- **27.** The vehicle front and near wind screen shall have 70% VLT (Visual Light Transmission) and side Glasses shall have 50% VLT respectively. Black film and any other material pasted on front and rear wind screen and side glass of the vehicle are not permitted.
- **28.** The vehicle should be owned by the successful tenderer or would have been leased to him/her during the period of contract. A copy of lease agreement shall be submitted when called for.
