The scheme will be executed with financial assistance from PFC/Other financial institutions and with APTRANSCO funding in case full loan is not sanctioned by PFC/Other financial institutions.

After careful consideration, APTRANSCO accords revised administrative approval for the above scheme at a total cost of Rs. 923.00 Lakhs as per the break up indicated below: The earlier administrative approval which was issued vide T.O.O. (CE/Construction) Ms. No.326 Dt. 09.11.2010. for Rs.856 Lakhs stands cancelled.
