## ORDER:-

According to the schedule announced by the Election Commission of India, polling for the Bye-election to 1-Sirpur, 2-Chennur (SC), 04-Mancherial 15-Yellareddy, 17-Nizamabad (Urban), 20-Koratla, 22-Dharmapuri (SC), 28-Vemulawada, 29-Sircilla, 31-Huzurabad 33-Siddipet and 105-Warangal West Assembly Constituencies in Adilabad, Nizamabad, Karimnagar, Medak and Warangal Districts will be held on 27.07.2010 (Tuesday) and the counting is on 30.07.2010 (Friday).

- 2. The State Government authorizes the Collector & District Election Officers of Adilabad, Nizamabad, Karimnagar, Medak and Warangal Districts to declare local holiday on the day before the day of poll i.e. on 26.07.2010 (Monday) and on the day of poll i.e., on 27.07.2010 (Tuesday) in the areas of the aforesaid Assembly Constituencies in connection with the conduct of Poll as large number of Public Buildings including Educational Institutions and other buildings will be utilized for the purpose of setting up of the polling stations and distribution centres in connection with conduct of Bye-Elections to Legislative Assembly. Similarly, the Collectors & District Election Officers of Adilabad, Nizamabad, Karimnagar, Medak and Warangal Districts are also authorized to declare a local holiday on the day fixed for counting if necessary. On local holidays the Treasuries and Sub-Treasuries in the District will however function.
- 3. Government also direct, that,
  - (i) the Labour, Employment Training & Factories Department to declare a paid holiday in the areas of 1-Sirpur, 2-Chennur (SC), 04-Mancherial 15-Yellareddy, 17-Nizamabad (Urban), 20-Koratla, 22-Dharmapuri (SC), 29-Sircilla, 31-Huzurabad 28-Vemulawada, 33-Siddipet 105-Warangal West Assembly Constituencies in Adilabad, Nizamabad, Karimnagar, Medak and Warangal Districts on the day of poll i.e. 27.07.2010 (Tuesday) under the A.P. Factories and Establishments Act, 1974 (AP Act No.32/1974) and A.P. Shops and Establishments Act, 1988 read with the provisions laid down in section 135-B of the R.P. Act, 1951 so as to enable the workers to exercise their franchise. Regarding the Industrial Undertakings / Establishments which are working on shift basis, it is certified that a holiday may be declared only for the shift during which the poll is to be taken, in view of the clarification issue by the Election Commission of India, in its letter No.78/99/PLN-1, Dt:06.04.1999.
  - (ii) the Commissioner of Labour, A.P. Hyderabad to declare a closed holiday in the areas of 1-Sirpur, 2-Chennur (SC), 04-Mancherial 15-Yellareddy, 17-Nizamabad (Urban), 20-Koratla, 22-Dharmapuri (SC), 28-Vemulawada, Sircilla, 31-Huzurabad 33-Siddipet and 105-Warangal West Assembly Constituencies in Adilabad, Nizamabad, Karimnagar, Medak and Warangal Districts on the day of poll i.e. 27.07.2010 (Tuesday) under the A.P. Shops and Establishments Act, 1988 (Act 20/1988) read with provisions laid down in Section 135-B (4) of R.P. Act, 1951, so as to exercise franchise;

- (iii) the Municipal Corporations, Municipal Committees and other Local Bodies and every University established by Central Provincial or State Act may also observe local holidays to be declared by the Collectors & District Election Officers as authorized by the Government on the day of poll i.e., 27.07.2010 (Tuesday)

The Government also direct that an employee ordinarily resident in the 1-Sirpur, 2-Chennur (SC), 04-Mancherial 15-Yellareddy, 17-Nizamabad (Urban), 20-Koratla, 22-Dharmapuri (SC), 28-Vemulawada, 29-Sircilla, 31-Huzurabad 33-Siddipet and 105-Warangal West Assembly Constituency areas, but having the place of work out side the Constituency area, may be given maximum facilities to exercise their right to vote, if his/her office does not happen to be closed on that particular day.
