The Ex-gratia amount for the year 2009-10 shall be payable subject to the following conditions.

- a) The Pay plus D.A. drawn for the period from 01.04.09 to 31.03.10 shall be added and the total amount calculated at 8.33% of this amount shall represent the Ex-gratia amount payable to employees. The payment of Ex-gratia is subject to a maximum of Rs.3,500/- only.
- b) The amount calculated as above shall be claimed in separate bills only and not clubbed with any other claim.
- c) The period of authorized leave i.e. Earned Leave, privilege leave sick leave, and casual leave with pay shall be considered as on duty for this purpose only.
- d) The period of Extra-Ordinary leave on loss of pay during 2009-10 shall not be counted for purpose of payment of Ex-gratia.
- e) Employees who are on rolls of APTRANSCO during 2009-10 but had worked only for part of the year shall be paid prorata.
- f) Employees who have put in less than 30 days attendance during 2009-10 shall not be eligible for payment of ex-gratia amount.
- g) Employees who have been dismissed for misconduct or who are under suspension pending disciplinary proceedings shall not be eligible for the payment of Ex-gratia amount. However, if as and when suspension, pending enquiries is withdrawn after finalization of the disciplinary proceedings, the employees would become eligible for being considered for payment of Ex-gratia.
- h) Earned Leave encashment drawn during the period 01.04.2009 to 31.03.2010 will not count for the total wages for determining the amount of Ex-gratia.
- i) Government personnel on deputation to the APTRANSCO during 2009-10 are also eligible for Ex-gratia payment. Common officers and staff who draw their pay and allowances from the Pay Officer or Accountant General are also eligible for Ex-gratia.
- j) The APTRANSCO Employees, who are on deputation to other departments etc., during 2009-10 are not eligible for Ex-gratia payment from the APTRANSCO Funds. They are however, eligible to draw Ex-gratia from the foreign employer.
- k) Application for LOC should contain the following information:
 - (a) Number of employees eligible for Ex-gratia up to Rs.3,500/-.
 - (b) Number of employees whose Ex-gratia is restricted to Rs.3,500/-.
