ORDER:

There are 13 SE/TL&SS Circles for O&M activities of 220KV & 132kV Sub-stations & Transmission lines, each Circle covering the jurisdiction of one to three Revenue Districts and 8 SE/TLC Circles for construction activities of 220KV & 132KV Sub-stations & Transmission lines, each Circle covering the jurisdiction of two to five Revenue Districts. There are also 3 SE/400KV(O&M) Circles for O&M of 400KV Sub-stations & Transmission lines and 2 SE/400KV(Construction) Circles for construction activities of 400KV Sub-stations & Transmission lines. It was decided in the KPI meeting dated 03/11/2010, to reorganize TL&SS and TLC wings and keep one SE in-charge of both the activities to have proper co-ordination and focused attention by reducing the jurisdiction to one Revenue District and a Committee was constituted vide T.O.O (Per-CGM/HRD&Trg)Rt.no.347, dt.17.11.11 to study the man power requirement. The said Committee after review of present set-up recommended for creation of 148 new posts in different categories required for restructuring of circles to be co-terminous with the districts and strengthening of Vidyutsoudha & field, to have better co-ordination with the various Officials in Power Sector and Government.

2. Proposal vide reference (1) cited was sent to Government for creation of new posts and the Government vide Letter No.1607/Ser/2012-3, dt.27.09.2013 communicated G.O.Ms.No.261, dt.26.09.2013 according sanction for creation of 88 new posts in different categories required for restructuring of circles to be co-terminous with the districts and strengthening of Vidyutsoudha & Field .
