## PROCEEDINGS:

As per the Commissioner (RD)/Director (RD) proceedings dt.09.09.2011, 1. 13.02.2012, 24.04.2012, 22.06.2012, 21.09.2012 & 22.01.2013 cited under references (1), (3), (5), (7), (9) & (11) an advance adhoc amount of Rs.10.00 Crores each time (total amount of Rs.60.00 Crores ) was transferred in proportion to four DISCOMs vide T.O.O's. dated 12-09-2011,27-02-2012,11-05-2012, 27.07.2012, 19-10-2012 & 05.02.2013 cited under references (2) ,(4), (6), (8), (10) & (12) respectively, under Comprehensive Land Development Programme (CLDP) and Indira Jala Prabha (IJP) programme in order to expedite the energization of bore-wells of SC/ST/BC & Others by developing required infrastructure.

- 2. Out of the above said, already disbursed advance adhoc amount of Rs.60.00 Crores, so far four DISCOMs have submitted UCs for an amount of Rs.34.31 Crores and balance amount of Rs.25.69 Crores is available with DISCOMs (EPDCL-Rs.2.61 Crores, SPDCL- Rs.14.21 Crores, CPDCL-Rs.7.19 Crores, NPDCL-Rs.1.68 Crores) for which UCs are yet to be furnished. Pending receipt of the UC's against the above said balance amount available with DISCOMs, the seventh advance adhoc installment amount is disbursed as follows as per the board proceedings towards the cost of energization of agricultural bore-wells under the IJP Scheme.
- 3. The Chairman & Managing Director/APTRANSCO hereby accords a sanction to transfer seventh installment adhoc advance amount of Rs.10.00 Crores (Rupees Ten Crores only) received from the Director (RD) vide proceedings dt.04.03.2013 cited under reference (13), (through the O/o the Commissioner, RD RIDF SBH, Adarshnagar Branch, SB. A/c.No. 62200343777) to the (SBH, Gunfoundry Branch, A/c.No. CA-52117469736 with IFSC Code.
