I acting for and on behalf of and by the order and direction of the TSTRANSCO accept your quotation cited for Procurement of spares required for Repairing of defective MICOM P643 Numerical differential relay (Sl.No.31044972/08/09) of 315 MVA ICT – I at 400KV SS Malkaram in Metro Zone, TSTRANSCO including repair charges as per the terms and conditions set out in this order.

1. SCOPE OF CONTRACT:

This contract relates to the Procurement of spares required for Repairing of defective MICOM P643 Numerical differential relay (Sl.No.31044972/08/09) of 315 MVA ICT – I at 400KV SS Malkaram in Metro Zone, TSTRANSCO including repair charges as per the terms and conditions set out in this order.

3. PRICES:

The Prices noted in schedule of materials are net, firm in rupees on FOR destination (TLC store, Erragadda, Hyderabad) basis. The value of purchase order is for Rs.35,647/- (Rupees Thirty Five thousand Six hundred and Forty seven only) after considering discount @ 7% towards cost of Material. The value of repair charges is of Rs. 12,696/- after considering discount @ 7% and is inclusive of [ST@12.36%](#) on service charge. The rate of entry tax, if applicable, as per the prevailing rate at the time of dispatch of the material.

4. TERMS OF PAYMENT: 100% payment along with Taxes and Duties shall be made against proforma invoices. You are requested to submit the proforma invoices separately in triplicate in advance to the Superintending Engineer/ O&M/400KV/Metro/Hyderabad for arranging payment towards material as well as service charges. No interest will be payable in case the payment is delayed for whatever reasons. However, the cheques will be handed over on receipt of the goods in good condition by authorized representative of Superintending Engineer/ O&M/ 400KV/ Metro/ Hyderabad. The regular invoice shall be sent to Superintending Engineer/O&M/400KV/Metro/Hyderabad for regularization.

5. DELIVERY:

Delivery shall be made immediately after receipt of commercially clear Purchase Order/Job Order.

6. DESPATCH INSTRUCTIONS:

You are requested to handover the MICOM P643 Numerical differential relay (Sl.No.31044972/08/09) after repair in full shape to authorized representative of Superintending Engineer/O&M/400KV/Metro/Hyderabad duly showing the work ability of the relay.

7. PAYING OFFICER:

The Paying Officer is Superintending Engineer/ O&M/400KV/Metro/Hyderabad / TSTRANSCO.

8. PACKING:

All the equipment shall be securely packed in such a manner as to withstand rough handling during rail and road transit up to site.

9. LOSS OR DAMAGE:

External damages or shortages that are prima-facie the result of rough handling in transit or due to defective packing will be intimated to you within a fortnight of receipt of materials. Internal defects, damages or shortage of any internal parts, which cannot ordinarily be detected on a superficial visual examination due to bad handling in transit or defective packing or other reasons, would be intimated within two months from the date of receipt. In either case the defective or damaged equipment should be replaced and the shortages made good by you free of cost to the TSTRANSCO.

10. MATERIAL AND WORKMANSHIP:

All the materials shall be of the best class and shall be capable of satisfactory operation in the tropics and other service conditions without distortion or deterioration of the appropriate Indian, British or America Standard. The workmanship shall be of the highest grade and the entire construction in accordance with the best modern practice.

11. WARRANTY:

Six months from the date of handing over of relay to the authorized representative of Superintending Engineer/O&M/400KV/Metro/Hyderabad. If any defects are noticed in the relay during the guarantee period, the material shall be replaced without any additional expenditure to TSTRANSCO.

12. JURISDICTION:

All and any disputes or differences arising out of or touching this order based on this Specification shall be decided by a panel of arbitrators.

i) Disputes involving amounts upto Rs.10,000/- and below.	Superintending Engineer of the TSTRANSCO the circle to which the disputes relates.
ii) Disputes involving amounts from Rs.10,000/- to Rs.50,000/-	Any Chief Engineer of the TSTRANSCO.
iii) There shall not be any reference of disputes, the value of which is above Rs.50,000/- to arbitration. The parties shall approach the competent civil courts in Hyderabad and Secunderabad having jurisdiction if any such dispute arise.
