**ORDER**

In exercise of powers delegated vide T.O.O.(P&G-Per) Ms.No.161, Dt:29-07-2006 as adopted by TSTRANSCO vide Office Order No.CGM(HRD, Trg & LIS)/DS(P)/AS/PO(IR&Reg)/JPO/01/14, Dt.12-06-2014, sanction is hereby accorded for payment of **Rs.1,44,055/-** (Rupees One Lakh Forty Four Thousand and Fifty Five only) towards TSPCC/TSDISCOMs share of 50% fee, clerkage and expenses to **Sri Rakesh K.Sharma, Advocate**, New Delhi towards work done as Advocate on Record in Civil Appeal No.4569/2003 and batch and CA.Nos.7029 to 7062 of 2008 filed before Hon'ble Supreme Court in the matter of collection of wheeling charges from the captive power units in the then unified Andhra Pradesh State.
