Whereas, in the reference 1 to 4 read above, under Reg.14(a)(1) of TSTRANSCO SRs Part-II, certain Senior Assistants were promoted temporarily as Junior Accounts Officers from the panels drawn on 01.02.2017, 09.09.2017, 10.02.2018 & 05.12.2018, keeping in view the exigencies of work and to suit administrative convenience:

- 2. The above promotion order was issued under Reg. 14 (a) (1) of APSEB Service Regulations Part-II as adopted by TS Transco subject to the following conditions:
  - (i) The promotions are liable for termination at anytime without notice and without assigning any reasons therefor;
  - (ii) The promotions are also subject to outcome of the Judgment in WP No. 16660 of 2015 & Batch of the Hon'ble High Court, which is the subject matter of CA.No.11435/2018 & Batch in the Hon'ble Supreme court; and also subject to outcome of Contempt Case D.No.28852/2020 in M.A.No.1270/2020 in CA.No.11435/2018 & Batch.
  - (iii) The promotions are also subject to the finalization of allocation of employees between APTRANSCO & TSTRANSCO and subsequent change in the seniority, if any.
  - (iv) The promotions shall be reviewed after completion of the process of final allocation of cadre strength, vacancies and employees between successor States by the Government and persons so promoted meanwhile shall not have any right on such promotion.
- 3. Whereas, as per the Judgments of the Hon'ble Supreme Court in the references read above, the allocation of employees between APTRANSCO & TSTRANSCO has attained finality. As such, in the reference 11<sup>th</sup> read above, the "inter-se-seniority" of the Petitioners vis-à-vis the employees working in TSTRANSCO as on 02-06-2014 has been fixed and drawn. Consequently, the previous seniority of Senior Assistants has undergone significant change, necessitating review of the panels drawn earlier based on the said seniority. As a result, the promotions ordered from the earlier panels dtd. 01.02.2017, 09.09.2017, 10.02.2018 & 05.12.2018 for promotion of Senior Assistants as Junior Accounts Officers shall also be required to be re-drawn.
- 4. Therefore, the earlier panel dtd.17-10-2015 drawn for promotion of Senior Assistants as Junior Accounts Officers has been re-drawn taking into consideration the "Inter-se-Seniority" now fixed as on 02-06-2014.
- 5. After careful consideration, the TSTRANSCO has decided to cancel the promotions ordered in the references 1 to 4 above read above, since the said promotions ordered therein were subject to the conditions as extracted at Para-2 above. Accordingly, the promotions ordered in respect of the following Senior Assistants as Junior Accounts Officers are hereby cancelled with immediate effect:
