In the reference 3rd cited, TSTRANSCO have directed all concerned Pension Disbursing Authorities to follow the instruction issued in T.O.O.No.(Addl.Secy-Per) Ms.No.401, dt.18.12.2010 & Memo dated 10.08.2011 scrupulously to issue identity cards to the Pensioners/Family Pensioners without fail.

2. In the reference 4th cited, the Convenor of Joint Negotiation Committee of All Pensioners' Associations of TSTRANSCO, TSGENCO, TSSPDCL & TSNPDCL have mentioned that some of the Pension Disbursing Authorities are not issuing laminated identity card to the Pensioners/Family Pensioners even after issuing TSTRANSCO instructions issued vide Memo dated 29.11.2018 and further mentioned that since the districts have been bifurcated and new Districts and new Circles have been formed it is quiet necessary to issue Laminated I.D.Cards and requested to issue new Laminated I.D.Cards with Joint Photo (wherever possible) to the Pensioners/Family Pensioners duly implementing the earlier orders on the subject matter.

3. After careful examination, TSTRANSCO hereby directs the Executive Director/Finance, Chief Engineer/Zones and Concerned Pension Disbursing Authorities to issue new Laminated Identity Cards with Joint Photo (wherever possible) to the Pensioners/Family Pensioners on their request duly following the instructions issued in the T.O.O.No.(Addl.Secy-Per)Ms.No.401, dt.18.12.2010, Memo dt.10.08.2011 & Memo dated 29.11.2018.
