In the G.O.2<sup>nd</sup> cited, Govt. of united AP have issued orders changing the existing periodicity from 8/16/24 to 6/12/18/24 years for appointments under the Automatic Advancement Scheme

2. The united APTRANSCO in T.O.O. 3<sup>rd</sup> cited, adopted the G.O 2<sup>nd</sup> cited and the Automatic Advancement Scheme was extended upto and below the scale of Rs.30600-1280-37000-1430-44150-1585-45735 (DE/SAO/AS cadres) i.e., as per the Revised Pay Scales, 2010.

3. In the reference 5<sup>th</sup> cited, TSTRANSCO adopted the existing Acts, Rules, Regulations, manuals, Specifications, Guidelines, Orders, Service Regulations, Conduct Rules etc., of APTRANSCO for TSTRANSCO mutatis mutandis w.e.f. 02.06.2014.

4. The issue of sanction of SPP I-A to certain employees in the cadre of DE and its equivalent cadres without getting promotion has come to the fore, as, the SGP scale of Divisional Engineer and its equivalent cadres is equivalent to the time scale of Superintending Engineer and its equivalent cadres.

5. After careful examination, TSTRANSCO hereby directs that an employee on completion of 12 years of service in the cadre of DE/SAO/AS shall be appointed to SPP-1A in the time scale of SE/Dy.CCA/DS by sanctioning one increment in the said scale.

6. These orders are issued with the concurrence of JMD (Finance, Comml, & HRD) vide Regd.No.3075, dt.26.07.2021.
