In the reference 2<sup>nd</sup> cited, TSTRANSCO has adopted the GO 1<sup>st</sup> cited for deferment of payment of wages / salaries, including all allowances and perks / pensions etc., to the employees / outsourcing / contract employees working in Government, PSUs / Government Aided Institutions / Organizations, keeping in view the economic impact caused due to lockdown and consequent lack of inflow of resources and in the view of additional expenditures being incurred to control COVID-19.

2. Accordingly, TSTRANSCO hereby directs all the Pay Drawing Officers to comply the following working instructions scrupulously without any deviation for deferment of Consolidated Remuneration / Honorarium / Salaries / Wages / Pensions in respect of Directors / OSDs / Employees / Artisans / Pensioners / Outsourced & Contract employees of TSTRANSCO from the gross salary for the month of March'2020 payable in April'2020 onwards till further orders:

| 2      | Directors / OSDs / Employees / Pensioners                         | 50%   |
| 3      | Class-IV Employees and Artisans / Outsourced & Contract Employees | 10%   |

3. Further, it is directed that the following statutory deductions from the salaries / wages / pensions of employees / Pensioners / Artisans / Contract & Outsourced personnel shall be effected for the month of March'2020 payable in April'2020 and will continue to be in force till further orders:

- i. EPF contribution on Basic Pay + DA
- ii. ESI contributions for Artisan Grade-IV
- iii. Professional Tax
- iv. GPF contribution @ 6% on Basic Pay.
- v. GSLIS/GIS/LIC premium/APGLIS
- vi. Self Funding Medical Scheme (SFMS)
- vii. All recoveries for the Police Personnel working in TSTRANSCO on deputation
- viii. Income Tax (TDS)
- ix. Other statutory deductions, if any.

4. The following deductions from salaries of employees shall be deferred until further orders:

- i. Departmental recoveries
- ii. Bank / Society Loan recovery.
- iii. GPF Loan / Advance recovery.
