In the Memo 3<sup>rd</sup> cited, TSTRANSCO has issued working instructions to all the Pay Drawing Officers of TSTRANSCO for deferment of salaries / pensions to the Employees/ Artisans/Pensioners from the gross salary / pension for the month of March'2020 payable in April'2020 onwards till further orders.

2. As per the Final Report dt.26-12-2019 and clarification dt.13-3-2020 issued by the Hon'ble Justice Sri D.M.Dharmadhikari, certain employees of APTRANSCO were allocated from APTRANSCO to TSTRANSCO. The allocated employees have reported to TSTRANSCO on 16-03-2020 (15-03-2020 being public holiday). Accordingly, TSTRANSCO has issued posting orders vide T.O.O. (CGM-HRD-Per) Ms.No.746 dt.09-04-2020 (Engineering & P&G employees) & T.O.O. (Jt.Secy-Per) Ms.No.748 dt.15-04-2020 (Accounts employees).

3. In continuation to the working instructions issued vide reference 3<sup>rd</sup> cited, all the Pay Drawing Officers of TSTRANSCO are hereby further directed to follow the following working instructions in respect of the employees allocated from APTRANSCO to TSTRANSCO:

- a. The allocated employees shall be paid Pay and Allowances for one-day Salary i.e., 15-03-2020 (journey time) immediately, with the rates applicable based on the Last Pay Certificate issued by previous station.
  - b. Pending re-fixation, the Gross Salary for the period from 15-03-2020 to 31-03-2020 shall be claimed duly keeping 50% of Gross Salary for the period from 16-03-2020 to 31-03-2020 as "Deferred Salary".
  - c. The allocated employees shall be paid Pay and Allowances w.e.f. 16-03-2020 onwards, with the rates applicable at the place of posting, subject to condition that the employees shall have reported for duty as per the posting orders issued by TSTRANSCO vide references 4<sup>th</sup> and 5<sup>th</sup> cited.
  - d. In respect of EPF holders, the EPF contributions shall be recovered on Basic Pay + DA for the balance period from 15-03-2020 to 31-03-2020, duly ensuring the Employee Pension Scheme (EPS) recovery already effected in previous station during the period from 01-03-2020 to 14-03-2020 as per EPF Act.
4. These orders are issued with the concurrence of Joint Managing Director (Fin., Comml., & HRD) vide Regd.No.1572, dt.17.04.2020.
