In accordance with G.O. 1st cited, TSTRANSCO in T.O.O.(Jt.Secy-Per) Ms.No.1348, dt.25.03.2022 issued orders for deduction of Telangana Green Fund contribution from the salaries of all the categories of regular employees of TSTRANSCO in the following pattern every year in the month of April, payable in the month of May, from the FY 2022-23:

1.	All India Service Officers	Rs.1200/- per annum
2.	All State Government Gazetted & Non- Gazetted Employees, Teachers, Grand-in-Aid employees including Corporations, Societies, Universities and Institutions under the control of State Government.	Rs.300/- per annum

2. In letter 3rd cited read with letter 4th cited, requested to take necessary action to implement the GOs 1st and 5th cited to deduct the amount towards “Telangana Green Fund” as per scale of pay.

3. In G.O 5th cited, the Government of Telangana ordered to deduct Telangana Green Fund contribution from the salaries/honorarium/remuneration of Public Representatives in the following pattern on every year April, payable in the month of May, from the financial year 2022-23.

S.No.	Cadre	Proposed Contribution
1.	Hon'ble Member of Parliament/ Member of Legislative Assembly/ Member of Legislative Council/ Chairmen's of Corporations	Rs.6,000/- per annum
2.	All Chairmen's of the Corporations and Chair Persons of Zilla Parishad	Rs.1,200/- per annum
3.	Chair Persons of Mandal Praja Parishad/ Zilla Parishad Territorial Constituency President	Rs.600/- per annum
4.	Mandal Parishad Territorial Constituencies, Corporators, Municipal Counsellors and Surpanches	Rs.120/- per annum

4. After careful examination, TSTRANSCO hereby directs the Pay Officer, TSTRANSCO to deduct an amount of Rs.1,200/- from the Honorarium/Remuneration of Chairman & Managing Director of TSTRANSCO every year in the month of April, payable in the month of May, from the FY 2022-23 towards contribution of Telangana Green Fund.
