If, she fail to join or evade joining within stipulated period or proceeding on leave from the date of receipt of this order, her right for promotion shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year, subject to availability of vacancy.

The promotion ordered in Para-1 above are subject to review as per the Clarification dtd.29.05.2021 issued by the Government of Telangana with regard to fixation of seniority based on "merit ranking"; and also in terms of the Circular Memo dtd.24-10-2019 issued by the Scheduled Castes Development Department, Government of Telangana on the implementation of the rule of reservation to SCs/STs in promotions conferring "consequential seniority" or otherwise and implementation of "catch-up rule".
