In the reference 8th cited, the TSTRANSCO issued orders for Revision of Pay Scales 2022 and Allowances in respect of Artisans w.e.f. 01.04.2022.

02. Whereas in reference 3rd cited, the TSTRANSCO issued orders to pay the wages to Artisans working in CBD gang as Artisan Grade - I instead of Artisan Gr.- II, Grade - III & Grade - IV irrespective of their Grades/technical/academic qualifications w.e.f. 29.07.2017 without changing their actual Grades.

03. Whereas in the Memos dt.20.2.2018, the TSTRANSCO issued orders to consider to pay wages to the Artisans working in SMG, Cable Gang of GIS & Cables sub-division, MRT assistants, Hot Line sub-divisions, Firemen drivers as per Artisan Grade-I and the Artisans working as Firemen, Cooks, Assistant Cooks, Sweet Maker, Tea/Coffee Makers, Carpenter, Plumber and Pump Operator working at Vidyut Soudha as per Artisan Grade-II instead Artisan Grade-III & Grade-IV irrespective of their Grades/technical/academic qualifications w.e.f. 29.07.2017 without changing their actual Grades.

04. Whereas in reference 6th cited, instructions were issued to the CE/Zones, CE/Civil, CE/Training, CE/IT, Joint Secretary and All Pay Drawing Officers that the Difference of the only Basic Pay shall be allowed and shown as **Special Pay** to the Artisans working at CBD gang, SMG, Cable Gang of GIS & Cables sub-division, MRT assistants, Hot Line sub-divisions, Firemen drivers as per Artisan Grade-I Basic Pay and the Artisans working as Firemen as per Artisan Grade-II Basic Pay and to the Artisans working as Cooks, Assistant Cooks, Sweet Maker, Tea/Coffee Makers, Carpenter, Plumber and Pump Operator as per Artisan Grade-II Basic Pay duly allowing the DA and HRA on their Actual Grades only.

05. After careful examination, the TSTRANSCO hereby directs the CE/Zones, CE/Civil, CE/Training, CE/IT, Joint Secretary and All Pay Drawing Officers that the **Special Allowance shall be paid @ 10% on MOGS on Revision of Pay Scales 2022** to the Artisan Grades - II, III & IV working at CBD gang, SMG, Cable Gang of GIS & Cables sub-division, MRT assistants, Hot Line sub-divisions, Firemen drivers and the Artisan Grades - III & IV working as Firemen, Cooks, Assistant Cooks, Sweet Maker, Tea/Coffee Makers, Carpenter, Plumber and Pump Operator without allowing the DA and HRA on Special Allowance.

06. The CE/Zones and Joint Secretary are hereby directed that Special Allowance shall be withdrawn, if the services of Artisans utilized other than services of CBD gang, SMG, Cable Gang of GIS & Cables sub-division, MRT assistants, Hot Line sub-divisions, Firemen drivers, Firemen, Cooks, Assistant Cooks, Sweet Maker, Tea/Coffee Makers, Carpenter, Plumber and Pump Operator.

07. The Chief Engineer/IT/TSTRANSCO is directed to make necessary changes in SAP without any deviation from above instructions.
