1. SCOPE OF CONTRACT

3. **DELIVERY:** You shall complete the supplies within three months from the date of this order.

4. PERFORMANCE SECURITY:

Performance Security for 10% of the contract value i.e. for Rs.2,60,662/- (Rupees Two Lakhs Sixty Thousand Six Hundred and Sixty Two Only) with a validity 60 days beyond the date of completion of performance obligations including warranty obligations is to be furnished.

In the event of any correction of defects or replacement of defective material during the warranty period, the warranty for the corrected/replaced material will be extended to a further period of 12 months and the Performance Bank Guarantee for proportionate value will be extended 60 days over and above the extended warranty period. It is entirely your responsibility to extend the validity of this Bank Guarantee to cover the period of guarantee well before its expiry.

5. **Payment Terms:** 100% payment will be arranged through PFC/REC/Bank/TSTransco/ Bulk Load funds within 45 days reckoned from the check measurement date in Form-13.

6. Warranty:

The material shall be guaranteed for satisfactory performance for a period of 18 months from the date of receipt of material/equipment at TLC stores or at site in good condition

against defects proved to be due to faulty design of material/workmanship. If during this period, any of the material is found defective they shall be repaired or replaced by you free of all costs to the TSTransco. To and fro freight charges shall also be to your account only.

7. All other terms and conditions indicated in the purchase order under reference cited above are applicable.
