I, acting for and on behalf of and by the order and direction of Transmission Corporation of Telangana Limited (hereinafter called the 'TSTransco'), place (Repeat+Extension) Order for supply of 450 Nos. 33 KV Solid Core Insulators, as per the provision of the clause 2(f) of the Purchase Order, SAP PO No. 4500002920/PMM/2019, Dt: 23.01.2020 with the same prices and Terms & Conditions set out in the Original Purchase order under reference(2) cited. This Order is in confirmation of your consent letter under reference (3) cited.

1. <u>SCOPE OF THE CONTRACT:</u>

The Contract relates to the supply of 450 Nos. 33 KV Solid Core Insulators and covers design, manufacture, testing before dispatch and delivery free at destination substations/stores (FADS) as detailed in this Order.

2. <u>SCHEDULE OF EQUIPMENT & PRICES:</u>

- a. The above price of 33 KV Solid Core Insulators is FIRM.
- b. The price is inclusive of all incidental charges such as Packing, Forwarding, Handling, Loading, Unloading and other incidentals.
- c. Freight & Insurance will be reimbursed on submission of documentary proofs only.
- d. The dispatch of equipment is by road only. The transit insurance shall be at least for an amount equal to 100% of the cost of the goods and include storage cover for 45 days at stores/site.
- e. It is to note that the prices are with the present rate of GST @ 18% on the total of Ex- Works, Freight and Insurance.
- f. The TSTransco shall have the right to vary the ordered quantity by $\pm 50\%$ at any time during the execution of the order.
- g. If any payment is made erroneously, TSTransco reserves the right to recover the same from your future bills/BGs.
- h. TCS @ 0.1% on sale amount is applicable on sale payment made, if company's aggregate sales consideration during the relevant financial year exceeds rupees fifty lakhs and total sales, gross receipts or total turnover including GST if any exceeds Rupees Ten Crores in the financial year immediately preceding the financial year of subject sales. The Payment of TCS shall be subjected to furnishing of necessary documents by the seller, which are to be verified by DDOs while processing the bills.
- 3. **<u>DELIVERY</u>**: To supply the total quantity within two months from the date of this Order.

4. <u>PERFORMANCE SECURITY:</u>

The supplier shall furnish to the purchaser the performance security for an amount equal to 10% of the total contract value i.e. **Rs.99,763.00** for proper fulfillment of the contract, which

will include the warranty period, and completion of performance obligations including warranty obligations. The performance security will cover 60 days beyond the date of completion of performance obligations including warranty obligations.

In the event of any correction of defects or replacement of defective material during the warranty period, the warranty for the corrected/replaced material will be extended to a further period of 12 months and the performance security for proportionate value will be extended 60 days over and above the extended warranty period. The proceeds of the performance security will be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete its obligations under the contract.

The performance security will be

- a) A Bank Guarant
- b)
- c) ee issued by a State Bank of India or its associate Banks / Nationalised bank acceptable to the Purchaser, in the form provided in the bidding documents.
- d) A Bankers Cheque or crossed DD or Pay Order at the Head Quarters of the Purchaser in favour of Pay Officer, TSTransco/Vidyut Soudha, Hyderabad, payable at Hyderabad drawn on any Scheduled Bank.

It is entirely your responsibility to extend the validity of this performance security to cover the period of Guarantee well before its expiry.

5. <u>TERMS OF PAYMENT</u>:

100% payment will be arranged through PFC/REC/Banks/TSTRANSCO/Bulk Load funds within 45 days reckoned from the check-measurement date in Form-13.

For payment through Real Time Gross Settlement (RTGS) the details of Bank Account of M/s. Hi Tech Insulators, Hyderabad are as below.

- a. The 100% payment mentioned above is subject to submission of performance security by the supplier as per clause (4) above.
- b. The supplier should invariably submit acceptance and routine test certificates and other documents the purchaser specifies before the dispatch is made so that they can be checked and approved well in advance.
- c. The performance guarantee to be executed in accordance with this specification will be furnished on a stamp paper of value Rs.100/-. The Bank Guarantee will be extended if

required suitably in accordance with the provisions of Performance Security clause of the specification.

- d. If the supplier has received any over payments by oversight or if any amounts are due to the TSTransco due to any other reasons, when it is not possible to recover such amounts under the contract resulting out of this specification, TSTransco reserves the right to collect the same from any other amount due to the supplier and / or Bank Guarantees given by the company due to or with TSTransco.
- e. When the supplier does not at any time, fulfill his obligations in replacing / rectifying etc. the damaged / defective materials in part or whole promptly to the satisfaction of the TSTransco Officers, TSTransco reserves the right not to accept the bills against subsequent dispatches made by the supplier and only the supplier will be responsible for any demurrages, wharfages or damage occurring to the consignments so dispatched.
- f. Any incidental charge such as stamp duty, bank charges etc., shall be to the Supplier's account and any charges in relation there to shall not be included in the bills submitted to TSTransco's Paying Officer through Banks.
- g. All payments will be made in non-convertible Indian Rupees.

6. <u>PENALTY FOR DELAY IN SUPPLIES:</u>

The time for and the dates for delivery mentioned in the contract will be deemed to be the essence of the contract. Subject to Force Majeure Clause as given at clause 10, if the Supplier fails to deliver any or all of the Materials or to perform the Services within the period(s) specified in the Contract, the Purchaser will, without prejudice to its other remedies under the Contract, deduct from the Contract Price, as liquidated damages, a sum equivalent to 0.5% per week on the undelivered portion subject to a maximum of 5% of the total value of the contract. Once the maximum is reached the Purchaser may consider termination of the contract.

The check measurement date in Form-13 i.e., the date of receipt of materials at destination stores in good condition will be taken as the date of delivery. Materials / Equipment which are not of acceptable quality or are not conforming to the specification would be deemed to be not delivered. For penalty, the number of days would be rounded off to the nearest week and penalty calculated accordingly.

The penalty specified above will be levied and would be adjusted against subsequent pending bills if required.

7. FORCE MAJEURE:

- a) The Supplier will not be liable for forfeiture of its performance security, penalty for late delivery, or termination for default if and to the extent that its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.
- b) For purposes of this clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseen. Such events may include, but are not restricted to wars or revolutions, fires, floods, epidemics, quarantine restrictions, and freight embargoes.

c) If a Force Majeure situation arises, the supplier promptly notify the Purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Supplier will continue to perform its obligations under the Contract as far as is reasonably

practice, and will seek all reasonable alternative means for performance not prevented by the Force Majeure event.

8. <u>WARRANTY:</u>

The supplier shall warrant for the satisfactory functioning of the material for a minimum period of 18 months from the date of receipt of the material at TLC Stores or at site in good condition against defects proved to be due to faulty design of material or workmanship. If during this period, if any of the material is found defective, they shall be repaired or replaced by you free of all costs to the TSTransco. In the event of any correction of defects or replacement of defective material during the warranty period, the warranty for the corrected/replaced material will be extended to a further period of 12 months. To and fro freight charges shall however be to your account only.

9. <u>ACKNOWLEDGEMENT:</u>

Please acknowledge the receipt of this purchase order with your confirmation of its acceptance and the extra copies enclosed may please be returned by signing on each and every page in token of your acceptance.

10. All other Terms and conditions mentioned in original purchase order under reference (2) cited, shall be applicable.
