After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Joint Managing Director (Fin, Comml. & HRD) hereby accords sanction for an amount of Rs.7,34,642/- (Rupees Seven Lakhs Thirty Four thousand Six hundred and Forty Two only) (an amount of Rs.5.00 Lakhs may be sanctioned from General Ceiling and Rs.2,10,297/- from SFMS 2020-21) to Yashoda Hospitals, Somajiguda, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.4,427/- (Rupee Four thousand Four hundred and Twenty Seven only) towards the excess amount claimed by Yashoda Hospitals, Somajiguda, Hyderabad.
