Pay Officer/TS Transco/VS/Hyderabad as in-patient for the period from 28-10-2021 to 6-11-2021 & 15-11-2021 to 24-11-2021 for “LRTI, Bilateral CAP, HTN (MM)” at Yashoda Hospitals, Malakpet, Hyderabad and requested to issue cheque in favour of M/s. Yashoda Health Care Services Pvt. Limited.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo. Dt.22-10-2020, the Joint Managing Director (Fin, Comml. & HRD) hereby accords sanction for an amount of Rs.2,43,133/- (Rupees Two Lakhs Forty Three thousand One hundred and Thirty Three only) to Yashoda Hospitals, Malakpet, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.1/- (Rupees One only) towards the excess amount claimed by Yashoda Hospital, Malakpet, Hyd.
3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.2,43,133/- (Rupees Four Two Lakhs Forty Three thousand One hundred and Thirty Three only) to M/s. Yashoda Health Care Services Pvt. Limited against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.
4. An amount of Rs.2,36,243/- is sanctioned to Smt. M.Susila, W/o. Late M.Satyanarayana, AO/Retd, I.D No.6600471 PPO No.11076 O/o. Pay Officer/TS Transco/VS/Hyderabad. A sum of Rs.6,890/- is recoverable from the pensioner. The Pay Officer/TSTransco/VS/Hyderabad is requested to recover the amount accordingly in instalments from the pension of the pensioner towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
