After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Joint Managing Director (Fin, Comml. & HRD) hereby accords sanction for an amount of Rs.2,32,769/- (Rupees Two Lakhs Thirty Two thousand Seven hundred and Sixty Nine only) to Yashoda Hospitals, Somajiguda, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.10,827/- (Rupee Ten thousand Eight hundred and Twenty Seven only) towards the excess amount claimed by Yashoda Hospitals, Somajiguda, Hyderabad.
