Pay Officer/TS Transco/VS/Hyderabad as in patient from 27-1-2022 to 12-2-2022 and 13-2-2022 to 18-2-2022 for “Covid-19, DM, HTN, AWTMI, Pulmonary Fibrosis, Dyselectrolytemia (MM)” at Care Hospitals, Banjara Hills, Hyderabad and requested to issue cheque in favour of Quality Care India Limited.

After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Chairman & Managing Director/TSTransco hereby accords sanction for an amount of Rs.14,85,260/- (Rupees Fourteen Lakhs Eighty Five Thousand Two Hundred and Sixty only) (an amount of Rs.6.0 lakhs sanctioned from SFMS 2021-22, Rs.4,80,000/- from General Ceiling and Rs.4,05,260/- from Major Ceiling) to Care Hospitals, Banjara Hills, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.28,352/- (Rupee Twenty Eight thousand Three hundred and Fifty Two only) towards the excess amount claimed by Care Hospitals, Banjara Hills, Hyderabad.
