### O R D E R:

M/s. Shree Meenakshi Eye Hospital, Nallakunta, Hyderabad has requested for new Empanelment of their hospital with TStranSCO for the benefit of Employees/ Pensioners/Artisans and their dependents and Family Pensioners for availing treatment on reimbursement basis.

2. After careful consideration, the Chairman & Managing Director/ TStranSCO hereby orders new empanelment of M/s. Shree Meenakshi Eye Hospital, Nallakunta, Hyderabad for the benefit of Employees/ Pensioners/ Artisans and their dependents and Family Pensioners for availing medical Eye treatment on reimbursement basis.

3. The new empanelment of M/s. Shree Meenakshi Eye Hospital, Nallakunta, Hyderabad is for a period of 1 (one) year from the date of issue of these orders. **The hospital is requested to submit the DME proceedings as and when received immediately.**

4. The new empanelment of the Hospital is subject to the condition that the management of the Hospital shall adopt the following procedure for reimbursement of bills:

- a) The rates for Eye treatment shall be charged as given in Annexure-I and II of G.O Ms.No.74, HM&FW(K1) Department, dt. 15-3-2005. **The credit letter will not be issued for the Eye treatments**, only reimbursement charges will be considered.

5. If any change in State Govt. regarding payments of Hospital bills/ reimbursement bills the same will be followed in TStranSCO.

6. The permission accorded to the hospital is liable for cancellation and such other action as deemed fit, including de-recognition of the hospital and initiate criminal action as per law against the hospital, whenever the TStranSCO forms the opinion based on inspection or enquiry into the allegations that the said private hospital is not providing treatment to the TStranSCO Employees/Pensioners/Artisans and their dependents and Family Pensioners etc., as stipulated above and violated the conditions mentioned therein, and indulge in any irregularities in respect of excess/bogus claims, cheating the patient of TStranSCO or resorting to any unlawful activities, etc., after giving fifteen (15) days notice to the hospital and pass appropriate orders, after considering the representation, if any, offered by the said hospital.

7. The new empanelled hospital will be considered based on Govt. approval from time to time. The hospital shall apply for renewal at least 15 days in advance from the date of its expiry, if not the name of the hospital will be removed from the empanelled hospitals list of TS Transco.

8. This order is issued with the concurrence of Joint Managing Director (Fin, Comml. & HRD) vide Regd.No.3847, dt. 30.8.2022.

9. This order comes into force from the date of issue of the order.
