ORDER:

In the reference 3<sup>rd</sup> cited, the Director, Yashoda Health Care Services Pvt. Limited, Malakpet, Hyderabad has preferred (2) No. credit medical bills amounting to Rs.3,61,250/- (Rupees Three Lakhs Sixty One Thousand Two Hundred and Fifty only) towards the medical treatment extended to Sri Y.Maheshwar, DE/Retd I.D No.6500940 O/o. Pay Officer/TSTransco/VS/Hyderabad as inpatient from 1-7-2022 to 13-7-2022 & 17-7-2022 to 21-7-2022 for “Pyrexia, Viral Severe Anaemia, Wide excision Tissue sarcoma, Haematoma (MM)” at Yashoda Health Care Services Pvt. Limited, Malakpet, Hyderabad and requested to issue cheque in favour of Yashoda Health Care Services Pvt. Limited.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo. dt. 22-10-2020, the Joint Managing Director (HRD) hereby accords sanction for an amount of Rs.3,39,150/- (Rupees Three Lakhs Thirty Nine Thousand One Hundred and Fifty only) from Major Ceiling to Yashoda Health Care Services Pvt. Limited, Malakpet, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.22,100/- (Rupees Twenty Two Thousand One Hundred only) towards the excess amount claimed by Yashoda Health Care Services Pvt. Limited, Malakpet, Hyderabad.

The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.3,39,150/- (Rupees Three Lakhs Thirty Nine Thousand One Hundred and Fifty only) from Major Ceiling to Yashoda Health Care Services Pvt. Limited against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.3,34,368/- is sanctioned to Sri Y.Maheshwar, DE/Retd I.D No.6500940 O/o. Pay Officer/TSTransco/VS/Hyderabad. A sum of Rs.4,782/- is recoverable from the Pensioner. The Pay Officer/VS/Hyderabad is requested to recover the amount accordingly in instalments from the pension of the pensioner towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)/TSTransco, within a month from the date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
