After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Joint Managing Director (Fin, Comml. & HRD) hereby accords sanction for an amount of Rs.5,81,741/- (Rupees Five Lakhs Eighty One Thousand Seven Hundred and Forty One only) from Major Ceiling to Care Hospitals, Banjara Hills, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.17,954/- (Rupee Seventeen Thousand Nine Hundred and Fifty Four only) towards the excess amount claimed by Care Hospitals, Banjara Hills, Hyderabad.
