**ORDER:**

In the reference 3<sup>rd</sup> cited, the Director, Yashoda Hospitals, Malakpet, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.5,40,607/- (Rupees Five Lakhs Forty Thousand Six Hundred and Seven only) towards the medical treatment extended to Sri Y.Shambi Reddy, F/o. Smt. Y.Krishnaveni, ADE I.D No.1071584 O/o. CE/Construction/TSTransco/VS/Hyderabad for “Sepsis, Urosepsis, Septic Shock with MODS AKI, Recurrent CVA, Left Hemiparesis MM” as in patient from 25-5-2023 to 4-6-2023 at Yashoda Hospitals, Malakpet, Hyderabad and requested to issue cheque in favour of Yashoda Health Care Services Pvt. Ltd.

2. After careful examination and as per Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, the Joint Managing Director (Fin, Comml. & HRD) as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with memo dt:22.10.2020 hereby accords sanction for an amount of Rs.5,38,950/- (Rupees Five Lakhs Thirty Eight Thousand Nine Hundred and Fifty only) from General Ceiling to Yashoda Hospitals, Malakpet, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.1,657/- (Rupee One Thousand Six Hundred and Fifty Seven only) towards the excess amount claimed by Yashoda Hospitals, Malakpet, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.5,38,950/- (Rupees Five Lakhs Thirty Eight Thousand Nine Hundred and Fifty only) from General Ceiling to Yashoda Health Care Services Pvt. Ltd. against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.5,28,651/- is sanctioned to Smt. Y.Krishnaveni, ADE I.D No.1071584 O/o. CE/Construction/TSTransco/VS/Hyderabad. A sum of Rs.10,299/- is recoverable from the Employee. The Pay Officer/VS/Hyderabad is requested to recover the amount accordingly in instalments from the salary of the employee towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)/TS Transco, within a month from the date of recovery from the salary of the employee concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
