ORDER:

In the reference 3<sup>rd</sup> cited, the Director, Yashoda Super Speciality Hospitals, Somajiguda, Hyderabad has preferred (5) No. credit medical bills amounting to Rs.6.55,639/- (Rupees Six Lakhs Fifty Five Thousand Six Hundred and Thirty Nine only) towards the medical treatment extended to Sri K.V.Ramakrishna, CE/Retd I.D No.6500464 O/o. Pay Officer/TSTransco/VS/Hyd and to his wife Smt. K.S.Lakshmi as in patient from 12-07-2023 to 07-08-2023, 22-08-2023 to 29-08-2023, 11-08-2023 to 28-09-2023, 23-09-2023 to 26-09-2023 & 19-09-2023 to 05-10-2023 for “Ca. Hypopharynx, Acute GE, CAD, HTN, Hyponatremia, UTI, Squamous Ca.” at Yashoda Super Speciality Hospitals, Somajiguda, Hyderabad and requested to issue cheque in favour of M/s. Yashoda Super Speciality Hospital.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by S Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Joint Managing Director (Fin, Comml. & HRD) hereby accords sanction for an amount of Rs.6,53,872/- (Rupees Six Lakhs Fifty Three Thousand Eight Hundred and Seventy Two only) to Yashoda Super Speciality Hospitals, Somajiguda, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.1,767/- (Rupees One Thousand Seven Hundred and Sixty Seven only) towards the excess amount claimed by Yashoda Super Speciality Hospitals, Somajiguda, Hyd.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.6,53,872/- (Rupees Six Lakhs Fifty Three Thousand Eight Hundred and Seventy Two only) to M/s. Yashoda Super Speciality Hospital against their credit bill under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.6,09,626/- is sanctioned to Sri K.V.Ramakrishna, CE/Retd I.D No.6500464 O/o. Pay Officer/TSTransco/VS/Hyd. (an amount of Rs.2,40,159/- is sanctioned from General Ceiling and Rs.3,69,467/- is sanctioned from Major Ceiling). A sum of Rs.44,246/- is recoverable from the Pensioner. The Pay Officer/ VS/Hyderabad is requested to recover the amount accordingly in instalments from the pension of the pensioner towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
