ORDER:

In the reference 4<sup>th</sup> cited, the Director, Yashoda Hospitals, Malakpet, Hyderabad has preferred (2) No. credit medical bill amounting to Rs.2,47,786/- (Rupees Two Lakhs and Forty Seven Thousand Seven Hundred and Eighty Six only) (2 Bills) towards the medical treatment to extended to Smt.K.Chennamma, W/o.Late Sri.K.Venkateswarlu, LI, (Retd), ID.No.6601019, O/o.SE/OMC-Circle/Nalgonda, as in-patient from 24.10.2023 to 03.11.2023 and 22.12.2023 to 23.12.2023 for “Surgery: Orif with PFN, Left IT Fracture Femur, new Onset Sezure, DM, HTN(MM)” at Yashoda Hospitals, Malakpet, Hyderabad and requested to issue a cheque in favour of “M/s Yashoda Health Care Services Pvt Ltd”.

2. After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt:22.10.2020, the JMD(HRD) hereby accords sanction for an amount of Rs.2,36,009/- (Rupees Two Lakhs Thirty Six Thousand and Nine only) (2Bills) for reimbursement of medical charges to Yashoda Hospitals, Malakpet, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.11,777/- (Rupees Eleven Thousand Seven Hundred and Seventy Seven only) towards the excess amount claimed by Yashoda Hospitals, Malakpet, Hyderabad.

The Pay Officer/TSTransco/VS/Hyderabad is requested to arrange for payment of Rs.2,36,009/- (Rupees Two Lakhs Thirty Six Thousand and Nine only) (2Bills) from General ceiling to M/s Yashoda Health Care Services Pvt Ltd against their credit bills under intimation to the Chief General Manager (HRD)/TSTransco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.2,33,361/- is sanctioned to Smt.K.Chennamma, W/o.Late Sri.K.Venkateswarlu, LI, (Retd), ID.No.6601019, O/o.SE/OMC-Circle/Nalgonda. A sum of Rs.2,648/- is recoverable from the Pensioner. The SE/OMC-Circle/Nalgonda is requested to recover amount from the pension in installments accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD)/TSTransco within a month from the last date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/Concerned Disbursing Officers.
