The Chief Engineer(IT) has submitted Budgetary proposals for Capital Works and R&M Works related to IT wing for the FY 2022-23 towards Procurement of Storage base for TSTRANSCO HPE Servers, Associated Switches, FC Cables and Accessories, Revamping of Local Area Network in Vidyut Soudha, Procurement of Desktop PCs, Establishment of WAN & LAN network equipment for 178Nos. EHV substations and 6Nos. Offices for accessing SAP ERP Business Operations for both Material & Services, Renewal of SAP Annual Technical Support Services (ATS) for TSTRANSCO for the calendar year 2022 for both old and New licenses. Obtaining Annual Maintenance Contract (AMC) support for HPE Servers, Storage, Switches and Tape Library, Procurement of 2 blocks additional Payroll and ESS Licenses (for JLM's) (1000 licenses), ATS for Sophos make UTM firewall at Vidyut Soudha and field offices for a period of 3years from Feb-2023, Repairs and Maintenance of TRANSCO ERP LAN Network at offices located in Erragadda etc,.

After careful consideration of the above proposals, TSTRANSCO hereby accords administrative approval for allocation of Budget for Rs.13.31Crores i.e. Rs.6.37 Crores towards Capital Works and Rs.6.94 Crores towards R&M Works planned in for the FY 2022-23 for IT Wing.

The expenditure towards the IT related Works shall be met from the Budget allocated and shall be chargeable to A/c.No.10-900 (for Capital works) and 74-800(for R&M works) respectively. The Pay Officer/TSTRANSCO/Vidyut Soudha is authorized to arrange payment of bills in respect of the proposed works.

These orders are issued with the concurrence of CMD/TSTRANSCO vide Regd.No. 717, dated:22.04.2022.
