ORDER:

In the reference cited, the Chief Engineer/ Metro Zone/Hyderabad, has sent proposal for according administrative approval for procurement of furniture for the use of 400KV GISS Raidurg under the control of the Superintendent Engineer/ OMC/ Metro-West /GTS Colony, Erragadda, Hyderabad, for an amount of Rs.2,66,860.32 (Rupees Two Lakh Sixty Six Thousand Eight Hundred and Sixty and Paise Thirty Two Only).

2. After careful examination, TSTRANSCO hereby accords administrative approval and authorization to Chief Engineer / Metro Zone/Hyderabad and also as per the least price quoted by M/s. VGreen Furnitures & Fixtures, Hyderabad, for an amount of Rs.2,66,860.32 (Rupees Two Lakh Sixty Six Thousand Eight Hundred and Sixty and Paise Thirty Two Only) towards procurement of furniture for use of 400KV GISS Raidurg under the control of the Superintendent Engineer/OMC/ Metro-West /GTS Colony, Erragadda, Hyderabad.

3. The expenditure for an amount of Rs.2,66,860.32 (Rupees Two Lakh Sixty Six Thousand Eight Hundred and Sixty and Paise Thirty Two Only) shall be met from TSTRANSCO Funds. The Budget Provision shall be ensured before issuing Tender Notification.

4. The Chief Engineer/ Metro Zone/Hyderabad, shall ensure the following before proceeding for procurement of furniture:

- i. The quantities and rates proposed in the Administrative Approval shall be ensured before issuing Tender Notification.
- ii. The actual amount of expenditure which will be incurred shall not exceed budget to be allocated.

5. The Chief Engineer/ Metro Zone/Hyderabad shall take further necessary action, duly following all the departmental procedures in vogue for procuring the furniture. The Budget should not exceed the given limit i.e., Rs.2,66,860.32 (Rupees Two Lakh Sixty Six Thousand Eight Hundred and Sixty and Paise Thirty Two Only).
