## ORDER:

After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, the JMD(HRD) as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt:22.10.2020, hereby accords sanction for an amount of Rs.3,19,744/-(Rupees Three Lakhs Nineteen Thousand Seven Hundred and Forty Four only) for reimbursement of medical charges to Yashoda Hospitals, Hitech City, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.18,245/-(Rupees Eighteen Thousand Two Hundred and Forty Five only) towards the excess amount claimed by Yashoda Hospitals, Hitech City, Hyderabad.
