**ORDER:**

In the reference 3<sup>rd</sup> cited, the Director, Yashoda Hospital, Secunderabad has preferred (1) No. credit medical bill amounting to Rs.2,17,733/- (Rupees Two lakhs seventeen thousand seven hundred and thirty three only) towards the medical treatment extended to Smt.V.Swapna, W/o.Sri V.Ramakrishna, ADE/Elecl., ID.No.1071258, O/o.SE/400 KV/Construction/Metro/Hyderabad as in-patient for the period from 19.04.2021 to 24.04.2021 for “Covid-19” at Yashoda Hospital, Secunderabad and requested to issue Cheque/DD in favour of M/s. Yashoda Health Care Services Pvt. Ltd.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TSTransco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt.22-10-2020, the Joint Managing Director (Finance, Commercial & HRD) hereby accords sanction for an amount of Rs.2,15,733/- (Rupees Two lakhs fifteen thousand seven hundred and thirty three only) to Yashoda Hospital, Secunderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.2,000/- (Rupees Two thousand only) towards the excess amount claimed by Yashoda Hospital, Secunderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.2,15,733/- (Rupees Two lakhs fifteen thousand seven hundred and thirty three only) to M/s. Yashoda Health Care Services Pvt. Ltd. against their credit bills under intimation to the Chief General Manager (HRD), TSTransco, Vidyut Soudha, Hyderabad

4. An amount of Rs.2,13,578/- is sanctioned to Sri V.Ramakrishna, ADE/Elecl., ID.No.1071258, O/o.SE/400 KV/Construction/Metro/Hyderabad. A sum of Rs.2,155/- is recoverable from the employee. The SE/400 KV/Construction/Metro/ Hyderabad is requested to recover the amount accordingly in instalments from the salary of the employee towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)/TSTransco, within a month from the date of recovery from the salary of the employee concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
