In the reference 1st cited, Sri A Narsing Rao, F/o. Late Sri A Raghavender Rao, (TSTRCORPOFF05353) who worked as Artisan Grade-IV, in O/o. CE/Constructions, Vidyut Soudha, expired on 04.08.2017 in Train accident has requested to provide a job to one of the family members and also sanction Rs.10 Lakhs towards Ex-gratia.

2. In the reference 3rd cited, the AS/Esst./TSTRANSCO/VS/Hyderabad has forwarded the family members certificate dt.12.06.2018 issued by Tahasildhar, Khairatabad Mandal and affidavit-cum-undertaking with regard to legal heir of Late Sri A Raghavender Rao, Artisan Grade-IV for arranging ex-gratia of Rs.10 Lakhs.

3. Accordingly, TS Transco hereby accords sanction for a sum of Rs.10,00,000/- (Rupees Ten Lakhs only) as ex-gratia on humanitarian grounds towards full & final settlement to Legal heir, Sri A Narsing Rao, F/o. Late A Raghavender Rao, Artisan Grade-IV worked in O/o. CE/Constructions at Vidyut Soudha and expired on 04.08.2017 in Train accident.

4. The Pay Officer/TSTRANSCO/VS/Hyderabad is hereby directed to arrange payment of Rs.10.00 Lakhs towards ex-gratia to Sri A Narsing Rao, F/o. Late A Raghavender Rao subject to the following conditions.

- a) The payment should be made without admitting any legal liability.
- b) An undertaking from the legal heir of the deceased worker shall be taken to the effect that there shall be no further liability to TSTRANSCO.
- c) Departmental Officers should make the actual payments directly to the legal heir and utmost care must be taken to ascertain the legal heirs. Proper receipts should be taken expressly reciting that the amount is received by the Legal Heir is in full and final settlement of claims against the TSTRANSCO.
