ORDER:

In the reference 4th cited, the Director, Aster Prime Hospital, Ameerpet, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.1,74,833/- (Rupees One Lakh Seventy Four Thousand Eight Hundred and Thirty Three only) towards the medical treatment extended to Sri. M. Anantha Chary, SK/Retired, ID No.6501207, O/o.SE/OMC/Metro-West/Hyderabad as inpatient from 03-11-2022 to 14-11-2022 for “B/1 pleural pneumonia lower limb cellulitis, AF with fever MM” at Aster Prime Hospital, Ameerpet, Hyderabad and requested to issue cheque in favour of Sri Sainatha Multi speciality Hospital Pvt. Ltd.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TSTransco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt.22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.1,48,681/- (Rupees One Lakh Forty Eight Thousand Six Hundred and Eighty One only) to Aster Prime Hospital, Ameerpet, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.26,152/- (Rupee Twenty Six Thousand One Hundred and Fifty Two only) towards the excess amount claimed by Aster Prime Hospital, Ameerpet, Hyderabad.

3. The Pay Officer/TSTransco/VS/Hyderabad is requested to arrange for payment of Rs.1,48,681/- (Rupees One Lakh Forty Eight Thousand Six Hundred and Eighty One only) to Sri Sainatha Multi speciality Hospital Pvt. Ltd. against their credit bill under intimation to the Chief General Manager (HRD)/TSTransco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.1,39,387/- is sanctioned to Sri. M. Anantha Chary, SK/Retired, ID No.6501207, O/o.SE/OMC/Metro-West/Hyderabad. A sum of Rs.9294/- is recoverable from the Pensioner. The SE/OMC/Metro-West/Hyderabad is requested to recover amount from the pension in installments accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD)/ TS Transco, within a month from the last date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/ Concerned Disbursing Officers.
