## ORDER

- 1) In accordance with the provisions of AP Reorganisation Act, 2014, the erstwhile APERC granted Transmission Licence No. 01 of 2014 to the Licensee (Transmission Corporation of Telangana Limited) vide APERC proceedings No. APERC/Secy/160/2014, Dated 11.07.2014.
- 2) The Commission had notified Regulation No.2 of 2016 (Levy of fees for various Services being rendered by the Commission) to be effective from 1st April, 2016 duly amending the Regulations 11 of 2013 & 1 of 2005 notified by the erstwhile APERC.
- 3) As per the provisions made under Sub-clause (2) of Clause (4) of Regulation 2 of 2016, the Transmission Licensee should pay the Annual License Fee @ Rs.2000/-per MW of the Allocated Contracted Capacity.
- 4) The Total Contracted Capacity projected for FY 2019-20 is 14,280 MW. It is considered to pay license fee on the 90% of projected capacity for FY 2019-20 which works out to Rs. 2.57 crores (14280 MW @ 90% @ Rs. 2000/- per MW), to avoid delayed payment interest 1.5 % p.m. (18.00% p.a.), since payment of license fee is mandatory.
- 5) The Govt. of Telangana permitted the licensee to continue with the existing Tariff for the FY 2019-20 till determination of tariffs by the TSERC. Accordingly, the Licensee has issued Public Notice on 29-03-2019.

- 6) Hence, TSTRANSCO hereby accords approval for payment of Rs. 2.57 Crores (Rupees Two Crores Fifty Seven Lakhs) towards Annual License Fee for Transmission License for FY2019-20.
- 7) The Pay Officer/TSTRANSCO/Vidyut Soudha/Hyderabad is authorized to draw the amount and arrange for payment in favour of "The Secretary, Telangana State Electricity Regulatory Commission, Hyderabad".
- 8) The expenditure is chargeable to account head 076-103 Annual Licence Fee.
