### ORDER:

The Government of Telangana vide reference 1<sup>st</sup> cited has re-appointed Sri R.Vinod Reddy, Advocate as Standing Counsel for TSTRANSCO and also appointed Smt.Veguru Umadevi, Advocate as Standing Counsel for representing TSTRANSCO and TSGENCO in Service Matters in High Court of Judicature at Hyderabad for a period of three years from the date of assumption of charge of the post or till termination of her services, whichever is earlier.

2. After careful consideration, the TSTRANSCO hereby adopts the orders issued in G.O.Rt.No.517, Law Department, Dt.10.10.2022 vide this order.

3. Consequent to their re-appointment/appointment as Standing Counsels to TSTRANSCO, Sri R.Vinod Reddy, Advocate is required to appear on behalf of TSTRANSCO in Non-Service matters and Smt.Veguru Umadevi, Advocate is required to appear on behalf of TSTRANSCO in Service Matters before the Hon'ble High Court of Judicature at Hyderabad. Their appointment is subject to the regulations governing appointment and payment of fee and expenses to Standing Counsels/SLAs issued vide reference 2<sup>nd</sup> & 3<sup>rd</sup> cited.

4. The Standing Counsels shall enter appearance in the Court cases as per the work allocation indicated below:

- (i) **Sri R.Vinod Reddy, Advocate** - All Writ Petitions, Writ Appeals, Contempt Cases and all other cases filed by /against TSTRANSCO/TSPCC in **Non-Service Matters** before Hon'ble High Court of Judicature at Hyderabad -.
- (ii) **Smt.Veguru Umadevi, Advocate** - All Writ Petitions, Writ Appeals, Contempt Cases and all other cases filed by /against TSTRANSCO/TSPCC in **Service Matters** before Hon'ble High Court of Judicature at Hyderabad -.
- (iii) The Standing Counsels are required to tender advice on matters referred to them by various Officers of the TSTRANSCO/TSPCC for legal opinion.
- (iv) They are required to inform time to time about the new cases filed against the TSTRANSCO/TSPCC, the cases heard and disposed off during the day, where judgments were delivered, the details of judgments along with his opinion whether there are any good grounds to file an appeal or not or any other important information to be conveyed to TSTRANSCO, so as to ensure follow up action promptly.

5. TSTRANSCO reserves its right to engage other Advocates before the Hon'ble High Court or any other Court or Tribunal as required from time to time.
