TSTRANSCO- Extension of 132kV power supply to Pumping Station No. 4 of SRLIP at Dibbagudem, Gadugulapalli (V) of Nagupalli Revenue Village, Dammapeta Mandal of Bhadradri Kothagudem District, on Satthupalli Main Canal for a load of 43.7MW under Sita Rama Lift Irrigation Scheme – **Bulk Load works** –Administrative Approval – Accorded.

PROCEEDINGS:

- 1. Chief Engineer, Irrigation, Bhadradri Kothagudem District vide reference cited above has requested for extending the power supply to Pumping Station No. 4 of SRLIP at Dibbagudem, Gadugulapalli (V) of Nagupalli Revenue Village, Dammapeta Mandal of Bhadradri Kothagudem District, on Sathupalli Main Canal for a load of 43.7MW under Sita Rama Lift Irrigation Scheme.
- 2. The power requirement details of pumping station is as follows:-

3. Accordingly, Sita Rama Lift Irrigation Scheme (Bulk Load works is formulated for extending of power supply to pumping station No.4 at Dibbagudem and the salient features of the scheme are as follows:

4. After careful examination, TSTRANSCO approved the scheme at a cost of Rs. 4428.96 Lakhs (Rupees Four Thousand Four Hundred Twenty Eight Lakhs and Ninety Six thousand only) including Development charges for the works of extension of power supply to pumping station at Dibbagudem (V) in Bhadradri Kothagudem District for a CMD of 46MVA at 132kV level as Bulk Load Works as detailed below.

^{**}The above charges of **Rs.460 Lakhs** and Service Connection Charges of Rs.30,000/-are required to be paid to TS NPDCL by I&CAD, Govt. of Telangana, at the time of release of service connection.

- 5. "In exercise of the powers conferred under section 164 of the Electricity Act,2003 Central Act No.36 of 2003, the Government of Telangana vide (G.O.Ms.No.115, dt.7.10.2003) conferred upon the Transmission Corporation of Telangana Limited, the Transmission Supply Licensee in the State of Telangana, Northern Power Distribution Company of Telangana Limited, Southern Power Distribution Company of Telangana Limited the distribution and retail supply licensee or their authorized representatives to have the powers for placing of the electric supply lines or telegraphic communications necessary for the proper co-ordination of works that a telegraphic authority possessed under the provision of the Indian Telegraph Act,1885 (Central Act 13 of 1885).
- 6. The sanction accorded in para-No. 4 above is subject to instructions issued by the TSTRANSCO on release of services and tariff as may be in force from time to time.
- 7. Chief Engineer/400kV/Vidyut Soudha/Hyderabad is hereby authorized to take up the works.
- 8. An amount of Rs. 4428.98 Lakhs shall be collected from Chief Engineer, Irrigation, Bhadradri Kothagudem for taking up the works by TSTRANSCO.
- 9. The order is issued with the concurrence of the Joint Managing Director (Finance, Comml. & HRD) /TSTRANSCO vide Regd. No.4096, Dt.4.10.2021.
