#### **ABSTRACT**

TSTRANSCO - Telecom - Provision of cellular connections in CUG to the employees of TSTRANSCO - Revision of ceiling limits - Orders - Issued.

#### ORDER:

Cellular connections have been provided in Cell One network of M/s. BSNL in Closed User Group (CUG) to the eligible employees of TSTRANSCO with different post paid plans duly limiting the payment of monthly cellular bills to the ceiling limits stipulated in the T.O.O 1<sup>st</sup> cited above and at present cellular connections of M/s. BSNL are being provided in CUG-199 plan.

In the CUG-50 and CUG-70 plans previously implemented, voice calls were free only within CUG group and calls for other than CUG numbers were charged according to the plan tariff rates. Due to decrease in cellular tariff rates in local market, M/s. BSNL is offering special CUG post paid plans like CUG-349 and CUG-199 with unlimited voice calls facility to TSTRANSCO from 01.10.2017 onwards.

At present CUG-199 plan with unlimited Voice & Data and 100 SMSs/day free is in implementation from 01.12.2018 to 30.11.2019 with tariff rates as indicated in T.O.O 2<sup>nd</sup> cited above. As unlimited Voice & Data are available in CUG-199 plan with monthly rental of Rs.235 including GST (Rental.199 +GST 18%), it is felt necessary to revise the ceiling limits stipulated in the above T.O.O as per the prevailing tariff rates.

After careful consideration, TSTRANSCO hereby orders that ceiling limits stipulated for payment of monthly cellular bills of all eligible employees irrespective of cadre is same as that of monthly rental of existing plan(CUG-199) i.e Rs. 235/- and it shall be implemented from 01.03.2019 until further orders.

Further in special cases when SMSs per day exceeds 100(free SMSs in CUG-199 plan), approval shall be given by the concerned Chief Engineer or equivalent for payment of excess SMSs charges duly verifying the claim of the employee.
