**ORDER:**

Govt. of Telangana vide G.O.Ms.No.64, Finance (HRM-VII) Department, Dt.15.06.2021 has revised the wages to the categories of Casual Labour/Daily Wage Worker, Full time contingent worker/Consolidated Pay Worker and Part time worker. The wages of Part Time worker was enhanced from Rs.4000/- per month to Rs.5200/- per month.

2. Accordingly, Transmission Corporation of Telangana Limited, after careful examination, directs that the rates of remuneration to the unskilled part-time contingent staff paid from contingencies working in TSTRANSCO shall be revised as Rs.5,200/- per month subject to following conditions:

- a) The part time contingent staff are not eligible for any percentage of DA and other allowances etc., in addition to the rates of remuneration fixed above.
- b) The Contingent staff are not full time workers and they are not eligible for EPF, ESI & minimum wages etc, since their wages are being paid under contingent basis.

3. The part time contingent staff should put in at least four hours of work per working day to get monthly rates of remuneration fixed in para-2 above. The rates of remuneration shall be proportionately reduced where the hours of work are less than four hours per day.

4. The revised rates of remuneration ordered in para-2 above shall come into force with effect from 01-11-2021.

5. These orders are issued with the concurrence of the JMD (Fin., Comml.,& HRD) vide Regd.No.4464, dt.16.11.2021.
