**ORDER:**

In the reference 4<sup>th</sup> cited, the Director, Yashoda Hospitals, Malakpet, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.3,09,832/- (Rupees Three lakhs nine thousand eight hundred and thirty two only) towards the medical treatment extended to Sri D.Ramesh, Artisan Gr.II, ID.No.50001179, O/o.SE/OMC/Nalgonda as in-patient for the period from 05.09.2020 to 11.09.2020 for “Bilateral Pneumonia, Covid-19 (Medical Management)” at Yashoda Hospitals, Malakpet, Hyderabad and requested to issue cheque in favour of M/s.Yashoda Health Care Services Private Limited.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt.22-10-2020, the Joint Managing Director (Finance, Commercial & HRD) hereby accords sanction for an amount of Rs.2,51,001/- (Rupees Two lakhs fifty one thousand and one only) from SFMS for F.Y.2020-21 to Yashoda Hospitals, Malakpet, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.58,831 /- (Rupee Fifty eight thousand eight hundred and thirty one only) towards the excess amount claimed by Yashoda Hospitals, Malakpet, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.2,51,001/- (Rupees Two lakhs fifty one thousand and one only) from SFMS for F.Y.2020-21 to M/s.Yashoda Health Care Services Private Limited against their credit bill under intimation to the Chief General Manager (HRD), Vidyut Soudha, Hyderabad.

4. An amount of Rs.2,44,934/- is sanctioned to Sri D.Ramesh, Artisan Gr.II, ID.No.50001179, O/o.SE/OMC/Nalgonda. A sum of Rs.6,067/- is recoverable from the Artisan. The SE/OMC/Nalgonda is requested to recover the amount accordingly in installments from the salary of the Artisan towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)/TS Transco, within a month from the date of recovery from the salary of the Artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
