PROCEEDINGS:

- 1. Chief Engineer, I&CAD, Bhadradri Kothagudem District vide reference cited above has requested for extending the power supply Pumping Station No. 4 of SRLIP at Dibbagudem, Gadugulapalli (V) of Nagupalli Revenue Village, Dammapeta Mandal of Bhadradri Kothagudem District, on Satthupalli Main Canal for a load of 43.7MW under Sita Rama Lift Irrigation Scheme.
- 2. The power requirement details of pumping station is as follows:-

- 3. Accordingly, TSTRANSCO formulated the scheme and administrative approval was accorded for "Sita Rama Lift Irrigation Scheme for pumping station 4 (Bulk Loads works) extension of power supply to Dibbagudem pumping station at an estimated cost of Rs. 4428.98 (including development charges) vide ref(2) cited above.
- 4. Consequently, the scheme for DC works under Sita Rama Lift Irrigation Scheme for pumping station 4 is formulated for extension of power supply to Dibbagudem pumping station. The scheme consisting of following substation.

- 5. After careful examination, TSTRANSCO accorded administrative approval at an estimate cost of **Rs.** 1251.87 Lakhs (Rupees One Thousand Two Hundred Fifty-One Lakhs and Eighty-Seven thousand only) for Sita Rama Lift Irrigation Scheme for pumping station 4 Deposit contribution the works of extension of power supply for a CMD of 46MVA at 132kV level to Dibbagudem pumping station.
- 6. "In exercise of the powers conferred under section 164 of the Electricity Act,2003 Central Act No.36 of 2003, the Government of Telangana vide (G.O.Ms.No.115, dt.7.10.2003) conferred upon the Transmission Corporation of Telangana Limited, the Transmission Supply Licensee in the State of Telangana, Northern Power Distribution Company of Telangana Limited, Southern Power Distribution Company of Telangana Limited the distribution and retail supply licensee or their authorized representatives to have the powers for placing of the electric supply lines or telegraphic communications necessary for the proper co-ordination of works that a telegraphic authority possessed under the provision of the Indian Telegraph Act,1885 (Central Act 13 of 1885).

- 7. The sanction accorded in para-No. 5 above is subject to instructions issued by the TSTRANSCO on release of services and tariff as may be in force from time to time.
- 8. Chief Engineer/400kV/Vidyut Soudha/Hyderabad is hereby authorized to take up the above works.
- 9. An amount of Rs. **1251.87** Lakhs shall be collected from the Chief Engineer, Irrigation, Bhadradri Kothagudem for taking up the works by TSTRANSCO.
- 10. The order is issued with the concurrence of the Joint Managing Director/ Finance, Comml. & HRD /TSTRANSCO vide Regd. No. 4096, Dt.04.10.2021.
