In exercise of powers delegated vide T.O.O.(P&G-Per) Ms.No.161, Dt:29-07-2006 as adopted by TSTRANSCO vide Office Order No.CGM(HRD, Trg & LIS)/DS(P)/AS/PO(IR&Reg)/JPO/01/14, Dt.12-06-2014, sanction is hereby accorded for payment of of **Rs.3,00,000/-** (Rupees Three Lakhs Only) towards Telangana Power Utilities share of remuneration (@50% of Rs.3,00,000/- per sitting) to **Sri D.M. Dharmadhikari**, former Judge, Supreme Court of India for the work done by him as **One Man Committee** on **02-03-2019 & 03-03-2019** (two sittings) at Hyderabad. Sanction is also accorded for payment of **Rs.54,000/-** (Rupees Fifty Four Thousand only) towards **GST @18%** on the remuneration sanctioned to the Justice D.M. Dharmadhikari former Judge Supreme Court of India.

2. The Pay Officer/TSTRANSCO, Vidyut Soudha, Hyderabad is requested to arrange payment of **Rs.3,00,000/-** (Rupees Three Lakhs Only) sanctioned in Para.1 above by cheque in favour of “**Sri D.M. Dharmadhikari**, Retd Judge, Hon’ble Supreme Court of India”, **Jabalpur**. It is also requested to arrange for remitting the **GST of Rs.54,000/-** (Rupees Fifty Four Thousand only) to **Service Tax Department, Govt of India**.

3. As the Committee appointed is towards formulating modalities for bifurcation of employees between T.S and A.P power utilities, the T.S power utilities share of remuneration to the Chairman of the said Committee along with applicable GST shall be shared equally among TSTRANSCO, TSGENCO, TSSPDCL & TSNPDCL as detailed below:

4. The Chief General Managers/Finance/ TSDISCOMs and FA&CCA/TSGENCO are requested to arrange for reimbursement of their respective share of allocated amounts in the form of Demand Draft in favour of “Pay Officer, TSTRANSCO, Vidyut Soudha, Hyderabad” payable at Hyderabad as detailed above.

5. The Executive Director (Finance), TSTRANSCO, Vidyut Soudha, Hyderabad is also requested to ensure that the reimbursement of above allocated amounts are received from the respective TSDISCOMs & TSGENCO.
