ABSTRACT

EXTENSIONS – Extension of Power Supply at 220 kV level to Pumping stations at Rampur, Rajeshwar Rao pet in Jagityal District and Puming station at Mupkal in Nizamabad district for a Load of 165.789 MVA under Lift Irrigation scheme along Flood Flow Canal (FFC) system for supplementation and Augmentation of Sriramsagar Project(SRSP) ayacut in Nizamabad and Jagityal Districts– Bulk Load Works – Revised Administrative Approval – Accorded.

PROCEEDINGS:

- 1. Chief Engineer (Projects), I&CAD, Karimnagar vide letter Dated 22-04-2017 has informed that Telangana State Government has accorded permission to lift 1 TMC of water per day for 60 days from Flood Flow Canal to Sriramsagar Project (SRSP) duly constructing 3 No. Pump houses at 3 Different location of existing Flood Flow Canal vide G.O.Rt.No.443 Irrigation and CAD (Projects-IV)Department Dated:20.04.2017 and requested to examine to provide suitable Sub Station and laying of transmission lines from nearest source to the Pump House Location.
- 2. The power requirement details at each pumping station is as follows:

Accordingly, Administrative approval was accorded vide T.O.O. Ms.No.24,
Dt.10.11.2017 as a single TOO for both Bulk Load and DC Works for Extension of 220 kV Power Supply to Pumping stations along Flood Flow Canal (FFC) system for

supplementation and Augmentation of Sriramsagar Project(SRSP) ayacut in Nizamabad and Jagityal Districts duly considering the approval for 10% Overhead Charges in 15th Board Meeting (dt:18.11.2016) and scheme cost was communicated to I&CAD Department.

- 4. Now the estimated cost of the scheme is revised due to the following:
 - a. Two separate TOOs are to be issued in order to separate **Bulk Load Works** (**up to metering arrangement**) and **Deposit Contribution works** for demarcation and capitalization of assets of TSTRANSCO up to metering arrangement.
 - b. Due to alternate connectivity to Rampur Pumping station by making LILO of 220kV RSS - Bheemgal Line to proposed Rampur SS.
 - c. Due to 2 Nos additional 220kV bays at Rampur SS for RSS-Bheemgal LILO line
 - d. Due to temporary alternate arrangement for 220kV DC line from Nirmal to Renjal by erecting 4 Nos 220kV towers adjacent to River crossing locations proposed for line.
- 5. Considering the above, the estimated cost of the scheme is revised and is as detailed below:

6. After careful consideration, TSTRANSCO approves the Scheme at a cost of **Rs.134.68 Crores** (Rupees One Hundred Thirty Four Crores and Sixty Eight Lakhs only) including 10% overhead charges for the works of extension of H.T supply to Pumping Stations at Rampur, Rajeshwar Rao pet in Jagityal District and Pumping station at Mupkal in Nizamabad district for a Load of 165.789 MVA under Lift Irrigation scheme along Flood Flow Canal (FFC) system for supplementation and Augmentation of Sriramsagar Project(SRSP) ayacut in Nizamabad and Jagityal Districts . This approval **supersedes** the approval given vide T.O.O under reference(3) cited above.

ordination of works that a telegraphic authority possessed under the provision of the Indian

Telegraph Act, 1885 (Central Act 13 of 1885)."

9. The sanction accorded in Para No.5 above is subject to instructions issued by the

TSTRANSCO on release of services and tariff as may be in force from time to time.

10. The works are under the scope of Chief Engineer/LIS/TSTRANSCO/VS/Hyderabad.

11. An amount of **Rs. 134.68 Crores** shall be collected as Deposit from Engineer – in – Chief

/I&CAD/ Projects /Karimnagar for carrying out the works by TSTRANSCO.

12. The order is issued with the concurrence of Joint Managing Director (Finance, Comml. &

HRD)/ TSTRANSCO vide Regd.No.3956, dated 14.10.2020.
