In the reference 4<sup>th</sup> cited, the Director, Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad has preferred (1) No. credit medical bill amounting to Rs.3,74,465/- (Rupees Three lakhs seventy four thousand four hundred and sixty five only) towards the medical treatment extended to Sri Shaik Razak F/o Smt Gousiya Begum, JLM, ID.No.1073808 O/o.SE/OMC/Khammam as in-patient on 12.04.2022 to 22.04.2022 for “Acute CVA, Pontine Bleed with LVH, AKI on CKD, DM, HTN (Medical Management)” at Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad and requested to issue cheque in favour of M/s.Yashoda Health Care Services Pvt. Ltd.

After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 and read with memo dt:22.10.2020, the Joint Managing Director (Fin., Comm. & HRD) hereby accords sanction for an amount of Rs.3,67,780/- (Rupees Three lakhs sixty seven thousand seven hundred and eighty only) for reimbursement of medical charges to Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.6,685/- (Rupees Six thousand six hundred and eighty five only) towards the excess amount claimed by Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad.

The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.3,67,780/- (Rupees Three lakhs sixty seven thousand seven hundred and eighty only) (from general ceiling) to M/s.Yashoda Health Care Services Pvt. Ltd. against their credit bill under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.3,48,974/- is sanctioned to Smt Gousiya Begum, JLM, ID.No.1073808 O/o.SE/OMC/Khammam. A sum of Rs.18,806/- is recoverable from the employee. The SE/OMC/Khammam is requested to recover amount from the salary in installments accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD)TS Transco within a month from the last date of recovery from the salary of the employee concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/Concerned Disbursing Officers.
