ORDER:

In the reference 4th cited, the Director, Krishna Institute of Medical Sciences Ltd., (KIMS), Minister Road, Secunderabad has preferred (1) No. credit medical bill amounting to Rs.3,99,044/- (Rupees Three lakhs ninety nine thousand and forty four only) towards the medical treatment extended to Kum. M.Hasini D/o Sri M.Mahesh, Artisan Gr-III, ID.No.2205 O/o.SE/OMC/Karimnagar as in-patient for the period from 03.12.2020 to 21.12.2020 for “Surgery Cervical Laminectomy, Evacuation Spinal Haematoma with Implants” at Krishna Institute of Medical Sciences Ltd., (KIMS), Minister Road, Secunderabad and requested to issue cheque in favour of Krishna Institute of Medical Sciences Limited.

After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 and read with memo dt:22.10.2020, the Joint Managing Director (Fin., Comml. & HRD) hereby accords sanction for an amount of Rs.3,89,038/- (Rupees Three lakhs eighty nine thousand and thirty eight only) for reimbursement of medical charges to Krishna Institute of Medical Sciences Ltd., (KIMS), Minister Road, Secunderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.10,006/- (Rupees Ten thousand and six only) towards the excess amount claimed by Krishna Institute of Medical Sciences Ltd., (KIMS), Minister Road, Secunderabad.

The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.3,89,038/- (Rupees Three lakhs eighty nine thousand and thirty eight only) to Krishna Institute of Medical Sciences Limited against their credit bill under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.3,85,092/- is sanctioned to Sri M.Mahesh, Artisan Gr-III, ID.No.2205 O/o.SE/OMC/Karimnagar. A sum of Rs.3,946/- is recoverable from the Artisan. The SE/OMC/Karimnagar is requested to recover amount from the salary in installments accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD)TS Transco within a month from the last date of recovery from the salary of the Artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/Concerned Disbursing Officers.
