ORDER:

In the reference 4<sup>th</sup> cited, the Director, Yashoda Hospitals, Somajiguda, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.2,67,505/-(Rupees Two Lakhs Sixty Seven Thousand Five Hundred and Five only) towards the medical treatment extended to Smt K.Mallamma, M/o Sri K.Chandra Sekhar, Artisan Gr.II, ID.No.50004760 O/o SE/OMC-Circle/Metro-West/Hyderabad as in-patient from 05.01.2023 to 14.01.2023 for “AML with Neutropenia” at Yashoda Hospitals, Somajiguda, Hyderabad and requested to issue a cheque in favour of “M/s Yashoda Super Speciality Hospital”.

2. After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, the Joint Managing Director (Fin, Comm. & HRD) as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt.22.10.2020, hereby accords sanction for an amount of Rs.2,57,402/- (Rupees Two Lakhs Fifty Seven Thousand Four Hundred and Two only) for reimbursement of medical charges to Yashoda Hospitals, Somajiguda, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.10,104/- (Rupees Ten Thousand One Hundred and Four only) towards the excess amount claimed by Yashoda Hospitals, Somajiguda, Hyderabad.

The Pay Officer/TSTransco/VS/Hyderabad is requested to arrange for payment of Rs.2,57,402/- (Rupees Two Lakh Fifty Seven Thousand Four Hundred and Two only) from claim falls under SFMS.FY 2022-2023 to M/s Yashoda Super Speciality Hospital, against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.2,55,559/- is sanctioned to Sri K.Chandra Sekhar, Artisan Gr.II, ID.No.50004760 O/o SE/OMC-Circle/Metro-West/Hyderabad. A sum of Rs.1,843/- is recoverable from the Artisan. The SE/OMC-Circle/Metro-West/Hyderabad is requested to recover the amount from the salary in installments accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD)TSTransco within a month from the last date of recovery from the salary of the Artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/Concerned Disbursing Officers.
