**ORDER:**

In the reference 3<sup>rd</sup> cited, the Director, Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad has preferred (1) No. credit medical bill amounting to Rs.3,86,443/- (Rupees Three lakhs eighty six thousand four hundred and forty three only) towards the medical treatment extended to Sri K.Koteswar Rao, F/o. Sri K.Dayakar, JPO ID.No.1073218, O/o.SE/OMC Circle/Metro Central/Hyderabad as in-patient for the period from 23.07.2020 to 30.07.2020 for **“Acute LRTI, Covid-19 Positive MM”** at Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad and requested to issue cheque in favour of M/s.Yashoda Health Care Services Private Limited.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt.22-10-2020, the Joint Managing Director (Finance, Commercial & HRD) hereby accords sanction for an amount of Rs.3,72,502/- (Rupees Three lakhs seventy two thousand five hundred and two only) from SFMS for F.Y.2020-21 to Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.13,941 /- (Rupee Thirteen thousand nine hundred and forty one only) towards the excess amount claimed by Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad.

The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.3,72,502/- (Rupees Three lakhs seventy two thousand five hundred and two only) from SFMS for F.Y.2020-21 to M/s.Yashoda Health Care Services Private Limited against their credit bills under intimation to the Chief General Manager (HRD), Vidyut Soudha, Hyderabad.

4. An amount of Rs.3,64,937/- is sanctioned to Sri K.Dayakar, JPO ID.No.1073218, O/o.SE/OMC Circle/Metro Central/Hyderabad. A sum of Rs.7,565/- is recoverable from the employee. The SE/OMC Circle/Metro Central/Hyderabad is requested to recover the amount accordingly in instalments from the salary of the employee towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD), within a month from the date of recovery from the salary of the employee concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
