**ORDER:**

In the reference 4<sup>th</sup> cited, the Director, Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad has preferred (1) No. credit medical bill amounting to Rs.7,35,706/- (Rupees Seven lakhs thirty five thousand seven hundred and six only) towards the medical treatment extended to Smt.K.Kalavathi, M/o.A.Kiran Kumar, ADE/Elecl., ID.No.1070848, O/o.SE/OMC/Metro-West/Hyderabad from 28.10.2020 to 08.11.2020 for “Covid-19 positive” at Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad and requested to issue cheque in favour of M/s.Yashoda Health Care Services Private Limited.

2. After careful examination and as per the minutes of CMD/TSTransco under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TSTransco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt.22-10-2020, the Joint Managing Director (Finance, Commercial & HRD) hereby accords sanction for an amount of Rs.7,35,706/- (Rupees Seven lakhs thirty five thousand seven hundred and six only) (An amount of Rs.6,00,000/- may be sanctioned from SFMS 2020-21 and Rs.1,35,706/- may be sanctioned from General Ceiling) to Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above.

The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of amount of Rs.7,35,706/- (Rupees Seven lakhs thirty five thousand seven hundred and six only) to M/s.Yashoda Health Care Services Private Limited (An amount of Rs.6,00,000/- may be sanctioned from SFMS 2020-21 and Rs.1,35,706/- may be sanctioned from General Ceiling) against their credit bills under intimation to the Chief General Manager (HRD), TSTransco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.7,12,033/- is sanctioned to Sri A.Kiran Kumar, ADE/Elecl., ID.No.1070848, O/o.SE/OMC/Metro-West/Hyderabad. A sum of Rs.23,673,- is recoverable from the employee. The SE/OMC/Metro-West/Hyderabad is requested to recover the amount accordingly in instalments from the salary of the employee towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD) within a month from the date of recovery from the salary of the employee concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
